R E S O L U T I O N No. 24-EF-721B

AMENDING THE PRIOR APPROVAL FOR FINANCIAL ASSISTANCE AUTHORIZED FOR A SPECIFIED PROJECT OF THE ENVIRONMENTAL FACILITIES CORPORATION (Drinking Water State Revolving Fund)

WHEREAS, the New York State Public Authorities Control Board ("PACB"), created pursuant to Chapter 38, Laws of 1976, as amended, is empowered by section 51 of the Public Authorities Law to receive applications from designated public benefit corporations, including the Environmental Facilities Corporation ("EFC"), for approval of the acquisition, construction or financing of any project by any such public benefit corporation; and

WHEREAS, EFC submits from time to time applications to PACB for approval of short-term and long-term financings as authorized in an EFC resolution duly adopted by EFC's Board of Directors; and

WHEREAS, PACB duly received an application from EFC for approval of short-term interest-free and short-term market-rate financings from available funding through the Drinking Water State Revolving Fund duly adopted by Resolution No. 2509 (the "EFC Resolution") at a meeting of EFC's Board of Directors held on August 10, 2017; and

WHEREAS, on August 16, 2017, PACB adopted Resolution No. 17-EF-721 (the "PACB Resolution"), approving the financings in the EFC Resolution, which included a \$581,782 short-term interest-free financing (the "Financing") to the Town of Prattsville (the "Recipient") under Project No. 15958; and

WHEREAS, on June 13, 2022, EFC's Board of Directors approved extension of the Financing's maturity date to September 14, 2024, through adoption of Resolution No. 2912; and

WHEREAS, PACB approved the amendment on June 15, 2022 through adoption of Resolution No. 22-EF-721A; and

WHEREAS, an extension of the Financing's maturity date is needed to ensure the Recipient has sufficient time to complete the project; and

WHEREAS, PACB has received an application (the "Application") from EFC seeking approval to amend the Financing authorized to the Recipient to provide for an extension of the Financing maturity date as authorized in an EFC resolution duly adopted at a meeting of EFC Board of Directors held on June 20, 2024; and


WHEREAS, this amendment of the PACB Resolution is specific to the Financing authorized to the Recipient and all other authorizations, determinations, terms and conditions contained in the PACB Resolution and subsequent amendments to said resolution shall remain in effect; and


WHEREAS, a copy of the Application has been filed with the Comptroller, and he has had the opportunity to comment.







Project Description

This project is for development of a new groundwater well to provide required source redundancy for the water system. The project also includes a new well house, including a master meter, treatment, controls, and auxiliary power, to replace the existing one; treatment of an existing well for bromomethane exceedances; replacement of all water meters with new remote read meters; and distribution system upgrades including hydrant replacement. The project is defined by the engineering report entitled "Water System Improvements Project" dated February 15th, 2017 by Lamont Engineers as may be updated, amended, supplemented, and approved by the Agency.
