Javits Convention Center authorized pursuant to section five of this act, including meeting and exhibition space and improvements to renovate the existing convention and exhibition facility, but not including any financing, funding, acquisition, leasing or renting of: (1) any space of facility that is at any time used as a professional sports facility and/or (2) any structure upon which any space or facility that is at any time used as a professional sports facility may be constructed.</p> <p>§2. Section 2 of chapter 35 of the laws of 1979 is amended by adding two new paragraphs as follows:</p> <p><u>"South parcel" means any real or personal property that is owned by the development corporation and generally bounded by west thirty-third street on the south, west thirty-fourth street on the north, twelfth avenue on the west and eleventh avenue on the east.</u></p> <p><u>"North parcel" means any real or personal property that is owned by the development corporation and generally bounded by west thirty-ninth street on the south, west fortieth street on the north, twelfth avenue on the west and eleventh avenue on the east."</u></p>
