economic development law, the tax law and the administrative code of the city of New York, in relation to establishing the New York innovation hot spot program (Part C); to amend the tax law and the administrative code of the city of New York, in relation to extending for three years the charitable contributions deduction limitation (Part D); to amend the tax law and the administrative code of the city of New York, in relation to the exclusion of certain royalty payments from the entire net income or other taxable basis of corporations, banking corporations, and insurance corporations, from the unrelated business income of corporations, and from the adjusted gross income of individual taxpayers; and to repeal certain provisions of the tax law relating thereto (Part E); to amend the tax law, in relation to the historic preservation tax credit (Part F); to amend the tax law, in relation to providing a tax credit for electric vehicle recharging property (Part G); to amend chapter 61 of the laws of 2011 amending the real property tax law and other laws relating to establishing standards for electronic real property tax administration, in relation to making permanent, provisions relating to mandatory electronic filing of tax documents and improving sales tax compliance and to repeal certain provisions of the tax law and the administrative code of the city of New York relating thereto (Part H); to amend the tax law, in relation to exempting sales made at a Taste-NY facility from sales and compensating use taxes; and to amend the alcoholic beverage control law, in relation to allowing sales of all types of alcoholic beverages at a Taste-NY facility (Part I); to amend the general municipal law and the public authorities law, in relation to industrial development agencies and authorities (Part J); to amend the tax law, in relation to expanding the exemption of CNG in the sales tax to include natural gas purchased and used to

produce CNG for use exclusively and directly in the engine of a motor vehicle (Part K); to amend the tax law, in relation to allowing voluntary ambulance services, fire companies, fire departments and rescue squads to claim reimbursement of the petroleum business tax for fuel used in their vehicles (Part L); to amend the tax law, in relation to the power of the commissioner of taxation and finance to refuse to issue a certificate of authority to collect the sales and use taxes and the power of the commissioner of taxation and finance to revoke such a certificate once granted and penalties related to the operation of a business without such certificate (Part M); to amend the tax law, in relation to allowing the department of taxation and finance to refuse a certificate of registration to retail dealers of cigarettes and tobacco products if such dealers have certain tax liabilities or have been convicted of a tax crime within one year of applying for or renewing a certificate of registration (Part N); to amend the tax law, in relation to increasing the penalty for the possession of unstamped and unlawfully stamped cigarettes (Part O); to amend the tax law, the vehicle and traffic law and the insurance law, in relation to the suspension of drivers' licenses of persons who are delinquent in the payment of past-due tax liabilities (Part P); to amend the tax law, in relation to serving an income execution with respect to individual tax debtors without filing a warrant (Part Q); to amend the tax law, in relation to the authority of counties to impose sales and compensating use taxes pursuant to the authority of article 29 of such law; and to repeal certain provisions of sections 1210 and 1224 and section 1210-E of such law relating thereto (Part R); to amend the tax law, in relation to a keno style lottery game (Part S); to amend the tax law, in relation to vendor fees paid to vendor tracks (Part T); and to amend the racing,

pari-mutuel wagering and breeding law, in relation to licenses for simulcast facilities, sums relating to track simulcast, simulcast of out-of-state thoroughbred races, simulcasting of races run by out-of-state harness tracks and distributions of wagers; to amend chapter 281 of the laws of 1994, amending the racing, pari-mutuel wagering and breeding law and other laws relating to simulcasting and chapter 346 of the laws of 1990, amending the racing, pari-mutuel wagering and breeding law and other laws relating to simulcasting and the imposition of certain taxes, in relation to making permanent certain provisions thereof; to amend the racing, pari-mutuel wagering and breeding law, in relation to making permanent certain provisions thereof; and to repeal subdivision 5 of section 1012 of the racing, pari-mutuel wagering and breeding law relating to telephone accounts and telephone wagering and section 1014 of the racing, pari-mutuel wagering and breeding law relating to simulcasting of out-of-state thoroughbred races (Part U)

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. This act enacts into law major components of legislation  
2 which are necessary to implement the state fiscal plan for the 2013-2014  
3 state fiscal year. Each component is wholly contained within a Part  
4 identified as Parts A through U. The effective date for each particular  
5 provision contained within such Part is set forth in the last section of  
6 such Part. Any provision in any section contained within a Part, includ-  
7 ing the effective date of the Part, which makes a reference to a section  
8 "of this act", when used in connection with that particular component,  
9 shall be deemed to mean and refer to the corresponding section of the  
10 Part in which it is found. Section three of this act sets forth the  
11 general effective date of this act.

12 PART A

13 Section 1. Subdivision 1 of section 183-a of the tax law, as amended  
14 by section 1 of part II-1 of chapter 57 of the laws of 2008, is amended  
15 to read as follows:

16 1. The term "corporation" as used in this section shall include an  
17 association, within the meaning of paragraph three of subsection (a) of  
18 section seventy-seven hundred one of the internal revenue code (includ-  
19 ing a limited liability company), a publicly traded partnership treated  
20 as a corporation for purposes of the internal revenue code pursuant to  
21 section seventy-seven hundred four thereof and any business conducted by  
22 a trustee or trustees wherein interest or ownership is evidenced by  
23 certificates or other written instruments. Every corporation, joint-  
24 stock company or association formed for or principally engaged in the  
25 conduct of canal, steamboat, ferry (except a ferry company operating  
26 between any of the boroughs of the city of New York under a lease grant-



1 ed by the city), express, navigation, pipe line, transfer, baggage  
2 express, omnibus, taxicab, telegraph, or telephone business, or formed  
3 for or principally engaged in the conduct of two or more such busi-  
4 nesses, and every corporation, joint-stock company or association formed  
5 for or principally engaged in the conduct of a railroad, palace car,  
6 sleeping car or trucking business or formed for or principally engaged  
7 in the conduct of two or more of such businesses and which has made an  
8 election pursuant to subdivision ten of section one hundred eighty-three  
9 of this article, and every other corporation, joint-stock company or  
10 association principally engaged in the conduct of a transportation or  
11 transmission business, except a corporation, joint-stock company or  
12 association formed for or principally engaged in the conduct of a rail-  
13 road, palace car, sleeping car or trucking business or formed for or  
14 principally engaged in the conduct of two or more of such businesses and  
15 which has not made the election provided for in subdivision ten of  
16 section one hundred eighty-three of this article, and except a corpo-  
17 ration, joint-stock company or association principally engaged in the  
18 conduct of aviation (including air freight forwarders acting as princi-  
19 pal and like indirect air carriers) and except a corporation principally  
20 engaged in providing telecommunication services between aircraft and  
21 dispatcher, aircraft and air traffic control or ground station and  
22 ground station (or any combination of the foregoing), at least ninety  
23 percent of the voting stock of which corporation is owned, directly or  
24 indirectly, by air carriers and which corporation's principal function  
25 is to fulfill the requirements of (i) the federal aviation adminis-  
26 tration (or the successor thereto) or (ii) the international civil  
27 aviation organization (or the successor thereto), relating to the exist-  
28 ence of a communication system between aircraft and dispatcher, aircraft

1 and air traffic control or ground station and ground station (or any  
2 combination of the foregoing) for the purposes of air safety and naviga-  
3 tion and except a corporation, joint-stock company or association which  
4 is liable to taxation under article thirty-two of this chapter, shall  
5 pay for the privilege of exercising its corporate franchise, or of doing  
6 business, or of employing capital, or of owning or leasing property in  
7 the metropolitan commuter transportation district in such corporate or  
8 organized capacity, or of maintaining an office in such district, a tax  
9 surcharge for all or any part of its years commencing on or after Janu-  
10 ary first, nineteen hundred eighty-two but ending before December thir-  
11 ty-first, two thousand [thirteen] eighteen, which tax surcharge, in  
12 addition to the tax imposed by section one hundred eighty-three of this  
13 article, shall be computed at the rate of eighteen percent of the tax  
14 imposed under such section one hundred eighty-three for such years or  
15 any part of such years ending before December thirty-first, nineteen  
16 hundred eighty-three after the deduction of any credits otherwise allow-  
17 able under this article, and at the rate of seventeen percent of the tax  
18 imposed under such section for such years or any part of such years  
19 ending on or after December thirty-first, nineteen hundred eighty-three  
20 after the deduction of any credits otherwise allowable under this arti-  
21 cle; provided, however, that such rates of tax surcharge shall be  
22 applied only to that portion of the tax imposed under section one  
23 hundred eighty-three of this article after the deduction of any credits  
24 otherwise allowable under this article which is attributable to the  
25 taxpayer's business activity carried on within the metropolitan commuter  
26 transportation district as so determined in the manner prescribed by the  
27 rules and regulations promulgated by the commissioner; and provided,  
28 further, that the tax surcharge imposed by this section shall not be

1 imposed upon any taxpayer for more than [three] four hundred [seventy-  
2 two] thirty-two months.

3 § 2. The opening paragraph of subdivision 1 of section 184-a of the  
4 tax law, as amended by section 2 of part II-1 of chapter 57 of the laws  
5 of 2008, is amended to read as follows:

6 The term "corporation" as used in this section shall include an asso-  
7 ciation, within the meaning of paragraph three of subsection (a) of  
8 section seventy-seven hundred one of the internal revenue code (includ-  
9 ing a limited liability company), and a publicly traded partnership  
10 treated as a corporation for purposes of the internal revenue code  
11 pursuant to section seventy-seven hundred four thereof. Every corpo-  
12 ration, joint-stock company or association formed for or principally  
13 engaged in the conduct of canal, steamboat, ferry (except a ferry compa-  
14 ny operating between any of the boroughs of the city of New York under a  
15 lease granted by the city), express, navigation, pipe line, transfer,  
16 baggage express, omnibus, taxicab, telegraph or local telephone busi-  
17 ness, or formed for or principally engaged in the conduct of two or more  
18 such businesses, and every corporation, joint-stock company or associ-  
19 ation formed for or principally engaged in the conduct of a surface  
20 railroad, whether or not operated by steam, subway railroad, elevated  
21 railroad, palace car, sleeping car or trucking business or principally  
22 engaged in the conduct of two or more such businesses and which has made  
23 an election pursuant to subdivision ten of section one hundred eighty-  
24 three of this article, and every other corporation, joint-stock company  
25 or association formed for or principally engaged in the conduct of a  
26 transportation or transmission business (other than a telephone busi-  
27 ness) except a corporation, joint-stock company or association formed  
28 for or principally engaged in the conduct of a surface railroad, whether

1 or not operated by steam, subway railroad, elevated railroad, palace  
2 car, sleeping car or trucking business or principally engaged in the  
3 conduct of two or more such businesses and which has not made the  
4 election provided for in subdivision ten of section one hundred eighty-  
5 three of this article, and except a corporation, joint-stock company or  
6 association principally engaged in the conduct of aviation (including  
7 air freight forwarders acting as principal and like indirect air carri-  
8 ers) and except a corporation principally engaged in providing telecom-  
9 munication services between aircraft and dispatcher, aircraft and air  
10 traffic control or ground station and ground station (or any combination  
11 of the foregoing), at least ninety percent of the voting stock of which  
12 corporation is owned, directly or indirectly, by air carriers and which  
13 corporation's principal function is to fulfill the requirements of (i)  
14 the federal aviation administration (or the successor thereto) or (ii)  
15 the international civil aviation organization (or the successor there-  
16 to), relating to the existence of a communication system between  
17 aircraft and dispatcher, aircraft and air traffic control or ground  
18 station and ground station (or any combination of the foregoing) for the  
19 purposes of air safety and navigation and except a corporation, joint-  
20 stock company or association which is liable to taxation under article  
21 thirty-two of this chapter, shall pay for the privilege of exercising  
22 its corporate franchise, or of doing business, or of employing capital,  
23 or of owning or leasing property in the metropolitan commuter transpor-  
24 tation district in such corporate or organized capacity, or of maintain-  
25 ing an office in such district, a tax surcharge for all or any part of  
26 its taxable years commencing on or after January first, nineteen hundred  
27 eighty-two, but ending before December thirty-first, two thousand [thir-  
28 teen] eighteen, which tax surcharge, in addition to the tax imposed by

1 section one hundred eighty-four of this article, shall be computed at  
2 the rate of eighteen percent of the tax imposed under such section one  
3 hundred eighty-four for such taxable years or any part of such taxable  
4 years ending before December thirty-first, nineteen hundred eighty-three  
5 after the deduction of any credits otherwise allowable under this arti-  
6 cle, and at the rate of seventeen percent of the tax imposed under such  
7 section for such taxable years or any part of such taxable years ending  
8 on or after December thirty-first, nineteen hundred eighty-three after  
9 the deduction of any credits otherwise allowable under this article;  
10 provided, however, that such rates of tax surcharge shall be applied  
11 only to that portion of the tax imposed under section one hundred eight-  
12 y-four of this article after the deduction of any credits otherwise  
13 allowable under this article which is attributable to the taxpayer's  
14 business activity carried on within the metropolitan commuter transpor-  
15 tation district; and provided, further, that the tax surcharge imposed  
16 by this section on corporations, joint-stock companies and associations  
17 formed for or principally engaged in the conduct of telephone or tele-  
18 graph business shall be computed in accordance with this subdivision and  
19 paragraph (c) of subdivision two of this section as if the three-quar-  
20 ters of one percent rate of tax provided for in subdivision one of  
21 section one hundred eighty-four of this article were applicable to such  
22 telephone and telegraph businesses for taxable years commencing on or  
23 after January first, nineteen hundred eighty-five and ending on or  
24 before December thirty-first, nineteen hundred eighty-nine; and  
25 provided, further, that the tax surcharge imposed by this section shall  
26 not be imposed upon any taxpayer for more than [three] four hundred  
27 [seventy-two] thirty-two months. Provided, however, that for taxable  
28 years beginning in two thousand and thereafter, for purposes of this

1 subdivision the tax imposed under section one hundred eighty-four of  
2 this article shall be deemed to have been imposed at the rate of three-  
3 quarters of one percent, except that in the case of a corporation,  
4 joint-stock company or association which has made an election pursuant  
5 to subdivision ten of section one hundred eighty-three of this article,  
6 for purposes of this subdivision the tax imposed under section one  
7 hundred eighty-four of this article shall be deemed to have been imposed  
8 at the rate of six-tenths of one percent.

9 § 3. Subparagraph 1 of paragraph (a) of subdivision 1 of section 186-c  
10 of the tax law, as amended by section 3 of part II-1 of chapter 57 of  
11 the laws of 2008, is amended to read as follows:

12 (1) Every utility doing business in the metropolitan commuter trans-  
13 portation district shall pay a tax surcharge, in addition to the tax  
14 imposed by section one hundred eighty-six-a of this article, for all or  
15 any parts of its taxable years commencing on or after January first,  
16 nineteen hundred eighty-two but ending before December thirty-first, two  
17 thousand [thirteen] eighteen, to be computed at the rate of eighteen  
18 percent of the tax imposed under section one hundred eighty-six-a of  
19 this article for such taxable years or any part of such taxable years  
20 ending before December thirty-first, nineteen hundred eighty-three after  
21 the deduction of any credits otherwise allowable under this article, and  
22 at the rate of seventeen percent of the tax imposed under such section  
23 for such taxable years or any part of such taxable years ending on or  
24 after December thirty-first, nineteen hundred eighty-three after the  
25 deduction of credits otherwise allowable under this article except any  
26 utility credit provided for by article thirteen-A of this chapter;  
27 provided, however, that such rates of tax surcharge shall be applied  
28 only to that portion of the tax imposed under section one hundred eight-

1 y-six-a of this article after the deduction of credits otherwise allow-  
2 able under this article, except any utility credit provided for by arti-  
3 cle thirteen-A of this chapter, which is attributable to the taxpayer's  
4 gross income or gross operating income from business activity carried on  
5 within the metropolitan commuter transportation district; and provided,  
6 further, that the tax surcharge imposed by this section shall not be  
7 imposed upon any taxpayer for more than [three] four hundred [seventy-  
8 two] thirty-two months.

9 § 4. Subdivision 1 of section 209-B of the tax law, as amended by  
10 section 4 of part II-1 of chapter 57 of the laws of 2008, is amended to  
11 read as follows:

12 1. For the privilege of exercising its corporate franchise, or of  
13 doing business, or of employing capital, or of owning or leasing proper-  
14 ty in a corporate or organized capacity, or of maintaining an office in  
15 the metropolitan commuter transportation district, for all or any part  
16 of its taxable year, there is hereby imposed on every corporation, other  
17 than a New York S corporation, subject to tax under section two hundred  
18 nine of this article, or any receiver, referee, trustee, assignee or  
19 other fiduciary, or any officer or agent appointed by any court, who  
20 conducts the business of any such corporation, for the taxable years  
21 commencing on or after January first, nineteen hundred eighty-two but  
22 ending before December thirty-first, two thousand [thirteen] eighteen, a  
23 tax surcharge, in addition to the tax imposed under section two hundred  
24 nine of this article, to be computed at the rate of eighteen percent of  
25 the tax imposed under such section two hundred nine for such taxable  
26 years or any part of such taxable years ending before December thirty-  
27 first, nineteen hundred eighty-three after the deduction of any credits  
28 otherwise allowable under this article, and at the rate of seventeen

1 percent of the tax imposed under such section for such taxable years or  
2 any part of such taxable years ending on or after December thirty-first,  
3 nineteen hundred eighty-three after the deduction of any credits other-  
4 wise allowable under this article; provided, however, that such rates of  
5 tax surcharge shall be applied only to that portion of the tax imposed  
6 under section two hundred nine of this article after the deduction of  
7 any credits otherwise allowable under this article which is attributable  
8 to the taxpayer's business activity carried on within the metropolitan  
9 commuter transportation district; and provided, further, that the tax  
10 surcharge imposed by this section shall not be imposed upon any taxpayer  
11 for more than [three] four hundred [seventy-two] thirty-two months.  
12 Provided however, that for taxable years commencing on or after July  
13 first, nineteen hundred ninety-eight, such surcharge shall be calculated  
14 as if the tax imposed under section two hundred ten of this article were  
15 imposed under the law in effect for taxable years commencing on or after  
16 July first, nineteen hundred ninety-seven and before July first, nine-  
17 teen hundred ninety-eight. Provided however, that for taxable years  
18 commencing on or after January first, two thousand seven, such surcharge  
19 shall be calculated using the highest of the tax bases imposed pursuant  
20 to paragraphs (a), (b), (c) or (d) of subdivision one of section two  
21 hundred ten of this article and the amount imposed under paragraph (e)  
22 of subdivision one of such section two hundred ten, for the taxable  
23 year; and, provided further that, if such highest amount is the tax base  
24 imposed under paragraph (a), (b) or (c) of such subdivision, then the  
25 surcharge shall be computed as if the tax rates and limitations under  
26 such paragraph were the tax rates and limitations under such paragraph  
27 in effect for taxable years commencing on or after July first, nineteen



1 hundred ninety-seven and before July first, nineteen hundred ninety-  
2 eight.

3 § 5. Subsection 1 of section 1455-B of the tax law, as amended by  
4 section 5 of part II-1 of chapter 57 of the laws of 2008, is amended to  
5 read as follows:

6 1. For the privilege of exercising its franchise or doing business in  
7 the metropolitan commuter transportation district in a corporate or  
8 organized capacity, there is hereby imposed on every taxpayer subject to  
9 tax under this article, other than a New York S corporation, for the  
10 taxable years commencing on or after January first, nineteen hundred  
11 eighty-two but ending before December thirty-first, two thousand [thir-  
12 teen] eighteen, a tax surcharge, in addition to the tax imposed under  
13 section fourteen hundred fifty-one of this article, at the rate of eigh-  
14 teen percent of the tax imposed under such section fourteen hundred  
15 fifty-one of this article, for such taxable years or any part of such  
16 taxable years ending before December thirty-first, nineteen hundred  
17 eighty-three after the deduction of any credits otherwise allowable  
18 under this article, and at the rate of seventeen percent of the tax  
19 imposed under such section for such taxable years or any part of such  
20 taxable years ending on or after December thirty-first, nineteen hundred  
21 eighty-three after the deduction of any credits otherwise allowable  
22 under this article; provided however, that such rates of tax surcharge  
23 shall be applied only to that portion of the tax imposed under section  
24 fourteen hundred fifty-one of this article after the deduction of any  
25 credits otherwise allowable under this article which is attributable to  
26 the taxpayer's business activity carried on within the metropolitan  
27 commuter transportation district; and provided, further, that the tax  
28 surcharge imposed by this section shall not be imposed upon any taxpayer

1 for more than [three] four hundred [seventy-two] thirty-two months.  
2 Provided however, that for taxable years commencing on or after July  
3 first, two thousand, such surcharge shall be calculated as if the rate  
4 of the basic tax computed under subsection (a) of section fourteen  
5 hundred fifty-five of this article was nine percent.

6 § 6. Paragraphs 1 and 3 of subdivision (a) of section 1505-a of the  
7 tax law, as amended by section 6 of part II-1 of chapter 57 of the laws  
8 of 2008, are amended to read as follows:

9 (1) Every domestic insurance corporation and every foreign or alien  
10 insurance corporation, and every life insurance corporation described in  
11 subdivision (b) of section fifteen hundred one of this article, for the  
12 privilege of exercising its corporate franchise, or of doing business,  
13 or of employing capital, or of owning or leasing property in the metro-  
14 politan commuter transportation district in a corporate or organized  
15 capacity, or of maintaining an office in the metropolitan commuter  
16 transportation district, for all or any part of its taxable years  
17 commencing on or after January first, nineteen hundred eighty-two, but  
18 ending before December thirty-first, two thousand [thirteen] eighteen,  
19 except corporations specified in subdivision (c) of section fifteen  
20 hundred twelve of this article, shall annually pay, in addition to the  
21 taxes otherwise imposed by this article, a tax surcharge on the taxes  
22 imposed under this article after the deduction of any credits otherwise  
23 allowable under this article as allocated to such district. Such taxes  
24 shall be allocated to such district for purposes of computing such tax  
25 surcharge upon taxpayers subject to tax under subdivision (b) of section  
26 fifteen hundred ten of this article by applying the methodology, proce-  
27 dures and computations set forth in subdivisions (a) and (b) of section  
28 fifteen hundred four of this article, except that references to terms

1 denoting New York premiums, and total wages, salaries, personal service  
2 compensation and commissions within New York shall be read as denoting  
3 within the metropolitan commuter transportation district and terms  
4 denoting total premiums and total wages, salaries, personal service  
5 compensation and commissions shall be read as denoting within the state.  
6 If it shall appear to the commissioner that the application of the meth-  
7 odology, procedures and computations set forth in such subdivisions (a)  
8 and (b) does not properly reflect the activity, business or income of a  
9 taxpayer within the metropolitan commuter transportation district, then  
10 the commissioner shall be authorized, in the commissioner's discretion,  
11 to adjust such methodology, procedures and computations for the purpose  
12 of allocating such taxes by:

13 (A) excluding one or more factors therein;

14 (B) including one or more other factors therein, such as expenses,  
15 purchases, receipts other than premiums, real property or tangible  
16 personal property; or

17 (C) any other similar or different method which allocates such taxes  
18 by attributing a fair and proper portion of such taxes to the metropol-  
19 itan commuter transportation district. The commissioner from time to  
20 time shall publish all rulings of general public interest with respect  
21 to any application of the provisions of the preceding sentence. The  
22 commissioner may promulgate rules and regulations to further implement

24 (3) Such tax surcharge shall be computed at the rate of eighteen  
25 percent of the taxes imposed under sections fifteen hundred one and  
26 fifteen hundred ten of this article as limited by section fifteen  
27 hundred five of this article, as allocated to such district, for such  
28 taxable years or any part of such taxable years ending before December

1 thirty-first, nineteen hundred eighty-three after the deduction of any  
2 credits otherwise allowable under this article, at the rate of seventeen  
3 percent of the taxes imposed under such sections as limited by section  
4 fifteen hundred five of this article, as allocated to such district, for  
5 such taxable years or any part of such taxable years ending on or after  
6 December thirty-first, nineteen hundred eighty-three and before January  
7 first, two thousand three after the deduction of any credits otherwise  
8 allowable under this article, and at the rate of seventeen percent of  
9 the taxes imposed under sections fifteen hundred one, fifteen hundred  
10 two-a, and fifteen hundred ten of this article, as limited or otherwise  
11 determined by subdivision (a) or (b) of section fifteen hundred five of  
12 this article, as allocated to such district, for such taxable years or  
13 any part of such taxable years ending after December thirty-first, two  
14 thousand two after the deduction of any credits otherwise allowable  
15 under this article; provided, however, that the tax surcharge imposed by  
16 this section shall not be imposed upon any taxpayer for more than  
17 [three] four hundred [seventy-two] thirty-two months. Provided however,  
18 that for taxable years commencing on or after July first, two thousand,  
19 and in the case of taxpayers subject to tax under section fifteen  
20 hundred two-a of this article, for taxable years of such taxpayers  
21 beginning on or after July first, two thousand and before January first,  
22 two thousand three, such surcharge shall be calculated as if (i) the  
23 rate of the tax computed under paragraph one of subdivision (a) of  
24 section fifteen hundred two of this article was nine percent and (ii)  
25 the rate of the limitation on tax set forth in section fifteen hundred  
26 five of this article for domestic, foreign and alien insurance corpo-  
27 rations except life insurance corporations was two and six-tenths  
28 percent.

1 § 7. This act shall take effect immediately.

2 PART B

3 Section 1. Paragraph 3 of subdivision (b) of section 24 of the tax  
4 law, as added by section 1 of part P of chapter 60 of the laws of 2004,  
5 is amended to read as follows:

6 (3) "Qualified film" means a feature-length film, television film,  
7 relocated television production, television pilot and/or each episode of  
8 a television series, regardless of the medium by means of which the  
9 film, pilot or episode is created or conveyed. "Qualified film" shall  
10 not include (i) a documentary film, news or current affairs program,  
11 interview or talk program, "how-to" (i.e., instructional) film or  
12 program, film or program consisting primarily of stock footage, sporting  
13 event or sporting program, game show, award ceremony, film or program  
14 intended primarily for industrial, corporate or institutional end-users,  
15 fundraising film or program, daytime drama (i.e., daytime "soap opera"),  
16 commercials, music videos or "reality" program, or (ii) a production for  
17 which records are required under section 2257 of title 18, United States  
18 code, to be maintained with respect to any performer in such production  
19 (reporting of books, films, etc. with respect to sexually explicit  
20 conduct).

21 § 2. Subdivision (b) of section 24 of the tax law is amended by adding  
22 a new paragraph 8 to read as follows:

23 (8) "Relocated television production" shall mean, notwithstanding the  
24 limitations in subparagraph (i) of paragraph three of this subdivision,  
25 a television production that is a talk or variety program that filmed at  
26 least five seasons outside the state prior to its first relocated season

1 in New York, the episodes are filmed before a studio audience of two  
2 hundred or more, and the relocated television production incurs (i) at  
3 least thirty million dollars in annual production costs in the state, or  
4 (ii) at least ten million dollars in capital expenditures at a qualified  
5 production facility in the state.

6 § 3. Paragraph 4 of subdivision (e) of section 24 of the tax law, as  
7 added by chapter 268 of the laws of 2012, is amended to read as follows:

8 (4) Additional pool 2 - The aggregate amount of tax credits allowed in  
9 subdivision (a) of this section shall be increased by an [addition]  
10 additional four hundred twenty million dollars in each year starting in  
11 two thousand ten[, four hundred twenty million dollars in two thousand  
12 eleven, four hundred twenty million dollars in two thousand twelve, four  
13 hundred twenty million dollars in two thousand thirteen and four hundred  
14 twenty million dollars in two thousand fourteen] through two thousand  
15 nineteen provided however, seven million dollars of the annual allo-  
16 cation shall be available for the empire state film post production  
17 credit pursuant to section thirty-one of this [chapter] article in two  
18 thousand thirteen and two thousand fourteen and twenty-five million  
19 dollars of the annual allocation shall be available for the empire state  
20 film post production credit pursuant to section thirty-one of this arti-  
21 cle in each year starting in two thousand fifteen through two thousand  
22 nineteen. This amount shall be allocated by the governor's office for  
23 motion picture and television development among taxpayers in accordance  
24 with subdivision (a) of this section. If the [director of the governor's  
25 office for motion picture and television development] commissioner of  
26 economic development determines that the aggregate amount of tax credits  
27 available from additional pool 2 for the empire state film production  
28 tax credit have been previously allocated, and determines that the pend-

1 ing applications from eligible applicants for the empire state film post  
2 production tax credit pursuant to section thirty-one of this [chapter]  
3 article is insufficient to utilize the balance of unallocated empire  
4 state film post production tax credits from such pool, the remainder,  
5 after such pending applications are considered, shall be made available  
6 for allocation in the empire state film tax credit pursuant to this  
7 section, subdivision thirty-six of section two hundred ten and  
8 subsection (gg) of section six hundred six of this chapter. Also, if  
9 the commissioner of economic development determines that the aggregate  
10 amount of tax credits available from additional pool 2 for the empire  
11 state film post production tax credit have been previously allocated,  
12 and determines that the pending applications from eligible applicants  
13 for the empire state film production tax credit pursuant to this section  
14 is insufficient to utilize the balance of unallocated film production  
15 tax credits from such pool, then all or part of the remainder, after  
16 such pending applications are considered, shall be made available for  
17 allocation for the empire state film post production credit pursuant to  
18 this section, subdivision forty-one of section two hundred ten and  
19 subsection (gg) of section six hundred six of this chapter. The gover-  
20 nor's office for motion picture and television development must notify  
21 taxpayers of their allocation year and include the allocation year on  
22 the certificate of tax credit. Taxpayers eligible to claim a credit  
23 must report the allocation year directly on their empire state film  
24 production credit tax form for each year a credit is claimed and include  
25 a copy of the certificate with their tax return. In the case of a quali-  
26 fied film that receives funds from additional pool 2, no empire state  
27 film production credit shall be claimed before the later of the taxable  
28 year the production of the qualified film is complete, or the taxable

1 year immediately following the allocation year for which the film has  
2 been allocated credit by the governor's office for motion picture and  
3 television development.

4 § 4. Paragraph 1 of subdivision (b) of section 24 of the tax law, as  
5 amended by section 6 of part Q of chapter 57 of the laws of 2010, is  
6 amended to read as follows:

7 (1) "Qualified production costs" means production costs only to the  
8 extent such costs are attributable to the use of tangible property or  
9 the performance of services within the state directly and predominantly  
10 in the production (including pre-production and post production) of a  
11 qualified film[, provided, however, that qualified production costs  
12 shall not include post production costs unless the portion of the post  
13 production costs paid or incurred that is attributable to the use of  
14 tangible property or the performance of services in New York in the  
15 production of such qualified film equals or exceeds seventy-five percent  
16 of the total post production costs spent within and without New York in  
17 the production of such qualified film].

18 § 5. Paragraph 3 of subdivision (a) of section 31 of the tax law, as  
19 added by section 12 of part Q of chapter 57 of the laws of 2010, is  
20 amended to read as follows:

21 (3) (i) A taxpayer shall not be eligible for the credit established by  
22 this section for qualified post production costs, excluding the costs  
23 for visual effects and animation, unless the qualified post production  
24 costs, excluding the costs for visual effects and animation, at a quali-  
25 fied post production facility meet or exceed seventy-five percent of the  
26 total post production costs, excluding the costs for visual effects and  
27 animation, paid or incurred in the post production of the qualified film  
28 at any post production facility. (ii) A taxpayer shall not be eligible



1 for the credit established by this section for qualified post production  
2 costs which are costs for visual effects or animation unless the quali-  
3 fied post production costs for visual effects or animation at a quali-  
4 fied post production facility meet or exceed three million dollars or  
5 twenty percent of the total post production costs for visual effects or  
6 animation paid or incurred in the post production of a qualified film at  
7 any post production facility, whichever is less. (iii) A taxpayer may  
8 claim a credit for qualified post production costs excluding the costs  
9 for visual effects and animation, and for qualified post production  
10 costs of visual effects and animation, provided that the criteria in  
11 subparagraphs (i) and (ii) of this paragraph are both satisfied. The  
12 credit shall be allowed for the taxable year in which the production of  
13 such qualified film is completed.

14 § 6. Section 3 of part Y-1 of chapter 57 of the laws of 2009, amending  
15 the tax law relating to the empire state film production credit, is  
16 amended to read as follows:

17 § 3. a. The governor's office of motion picture and television devel-  
18 opment shall file a report on a quarterly basis with the director of the  
19 division of the budget and the chairmen of the assembly ways and means  
20 committee and senate finance committee. The report shall be filed within  
21 fifteen days after the close of the calendar quarter. The first report  
22 shall cover the calendar quarter that begins April 1, 2009. The report  
23 must contain the following information for the calendar quarter:

24 (1) the total dollar amount of credits allocated during each month of  
25 the calendar quarter, broken down by month;

26 (2) the number of film projects which have been allocated tax credits  
27 of less than \$1 million per project and the total dollar amount of cred-  
28 its allocated to those projects;

1 (3) the number of film projects which have been allocated tax credits  
2 of \$1 million or more but less than \$5 million per project and the total  
3 dollar amount of credits allocated to those projects;

4 (4) the number of film projects which have been allocated tax credits  
5 of \$5 million or more per project and the total dollar amount of credits  
6 allocated to those projects; [and]

7 (5) a list of each film project which has been allocated a tax credit  
8 and for each of those projects (a) the estimated number of employees  
9 associated with the project, (b) the estimated qualified costs for the  
10 project, [and] (c) the estimated total costs of the project, and (d) the  
11 credit-eligible man hours for each project; and

12 (6)(a) the name of each taxpayer allocated a tax credit for each  
13 project; provided however, if the taxpayer claims a tax credit because  
14 the taxpayer is a member of a limited liability company, a partner in a  
15 partnership or a shareholder in a subchapter S corporation, the name of  
16 each limited liability company, partnership or subchapter S corporation  
17 earning any of those tax credits must be included in the report instead  
18 of information about the taxpayer claiming the tax credit, (b) the  
19 amount of tax credit allocated to each taxpayer; provided however, if  
20 the taxpayer claims a tax credit because the taxpayer is a member of a  
21 limited liability company, a partner in a partnership or a shareholder  
22 in a subchapter S corporation, the amount of tax credit earned by each  
23 entity must be included in the report instead of information about the  
24 taxpayer claiming the tax credit, and (c) information identifying the  
25 project associated with each taxpayer for which a tax credit was claimed  
26 under section 24 or section 31, as added by chapter 57 of the laws of  
27 2010, of the tax law, including the name of the film and county in which  
28 the project is located; and

1 b. The governor's office of motion picture and television development  
2 shall file a report on a biennial basis with the director of the divi-  
3 sion of the budget and the chairs of the assembly ways and means commit-  
4 tee and senate finance committee. The report shall be filed within  
5 fifteen days after the close of the calendar year. The first report  
6 shall cover a two year period that begins on January first, two thousand  
7 thirteen. The report must be prepared by an independent third party  
8 auditor and include: (1) information regarding the empire state film  
9 production credit and post production credit programs including the  
10 efficiency of operations, reliability of financial reporting, compliance  
11 with laws and regulations and distribution of assets and funds; (2) an  
12 economic impact study prepared by an independent third party of the film  
13 credit programs; and (3) any other information and/or other statistical  
14 information that the commissioner of economic development deems to be  
15 useful in analyzing the effects of the program.

16 § 7. This act shall take effect immediately, provided, however, that  
17 sections four and five of this act shall apply to taxpayers submitting  
18 initial applications to the governor's office of motion picture and  
19 television development on or after the date this act shall have become a  
20 law, and to taxpayers who filed an initial application before this act  
21 shall have become a law but who have not yet submitted a final applica-  
22 tion to the governor's office of motion picture and television develop-  
23 ment on or before the date this act shall have become a law; and the  
24 amendments made to section 3 of part Y-1 of chapter 57 of the laws of  
25 2009, amending the tax law relating to the empire state film production  
26 credit, with the exception of subdivision b of such section, shall only  
27 apply to taxpayers submitting initial applications to the governor's

1 office of motion picture and television development on or after the date  
2 this act shall become a law.

3 PART C

4 Section 1. Legislative intent. This act is intended to create a state-  
5 wide network of university affiliated or college affiliated and private  
6 sector affiliated innovation hot spots in New York state to support  
7 start-up companies and those in the early stage of development. The  
8 mission of the innovation hot spots shall be to promote job creation,  
9 entrepreneurship and technology transfer, as well as to provide support  
10 services to hot spot tenants, including, but not limited to, business  
11 planning, management assistance, financial-packaging, linkages to  
12 financing and technology services, and coordination with other sources  
13 of assistance.

14 § 2. The economic development law is amended by adding a new section  
15 361 to read as follows:

16 § 361. New York innovation hot spot program. 1. Definitions. As used  
17 in this section, the following terms shall have the following meanings:

18 (a) "Innovation hot spot" shall mean a facility or facilities desig-  
19 nated as such by the commissioner.

20 (b) "Qualified entity" shall mean a business enterprise that is:

21 (i) in the formative stage of development;

22 (ii) located in New York state;

23 (iii) either: (A) any corporation, except a corporation which:

24 (1) over fifty percent of the number of shares of stock entitling the  
25 holders thereof to vote for the election of directors or trustees is  
26 owned or controlled, either directly or indirectly, by a taxpayer

1 subject to tax under the following provisions of the tax law: article  
2 nine-A; section one hundred eighty-three, one hundred eighty-four or one  
3 hundred eighty-five of article nine; article thirty-two or article thir-  
4 ty-three; or

5 (2) is substantially similar in operation and in ownership to a busi-  
6 ness entity (or entities) taxable or previously taxable under the  
7 following provisions of the tax law: article nine-A; section one hundred  
8 eighty-three, one hundred eighty-four, one hundred eighty-five or former  
9 section one hundred eighty-six of article nine; article thirty-two;  
10 article thirty-three; article twenty-three, or would have been subject  
11 to tax under such article twenty-three (as such article was in effect on  
12 January first, nineteen hundred eighty) or the income (or losses) of  
13 which is (or was) includable under article twenty-two; or

14 (B) a sole proprietorship, partnership, limited liability company, or  
15 New York subchapter S corporation that is not substantially similar in  
16 operation and in ownership to a business entity (or entities) taxable,  
17 or previously taxable, under article nine-A of the tax law, section one  
18 hundred eighty-three, one hundred eighty-four, one hundred eighty-five  
19 or former section one hundred eighty-six of article nine of the tax law,  
20 article thirty-two or thirty-three of the tax law, article twenty-three  
21 of the tax law or which would have been subject to tax under such arti-  
22 cle twenty-three (as such article was in effect on January first, nine-  
23 teen hundred eighty) or the income (or losses) of which is (or was)  
24 includable under article twenty-two of the tax law; and

25 (iv) is approved to locate in an innovation hot spot by the operator  
26 of such innovation hot spot.

27 (c) "Operator of an innovation hot spot" shall mean:

1 (i) an accredited post-secondary educational institution, college or  
2 university; not-for-profit entity affiliated with a higher educational  
3 institution; or, collaborative enterprise between one or more accredited  
4 post-secondary educational institution, college or university and not-  
5 for-profit entity affiliated with a higher educational institution;

6 (ii) located in New York state; and

7 (iii) designated by the commissioner to operate a facility that  
8 provides: low-cost space; technical assistance; support services,  
9 including, but not limited to, central services; and, educational oppor-  
10 tunities, to a "qualified entity."

11 2. The commissioner shall:

12 (a) solicit applications from post-secondary educational institutions,  
13 colleges, universities, or not-for-profit entities affiliated with a  
14 higher education institution or collaborative enterprises between one or  
15 more accredited post-secondary educational institutions, colleges, or  
16 universities and not-for-profit entities for approval to operate inno-  
17 vation hot spots in property owned or leased by such entities to attract  
18 industries with significant potential for economic growth and develop-  
19 ment in New York state, and identify technological areas that can  
20 contribute to the growth of various industries located throughout New  
21 York state;

22 (b) receive recommendations from the regional economic development  
23 councils regarding the approval or rejection of the applicants as opera-  
24 tors of innovation hot spots.

25 3. The commissioner shall establish criteria concerning the innovation  
26 hot spot program. (a) The criteria that applicants must satisfy to be  
27 designated as an operator of an innovation hot spot include, but are not  
28 limited to, the following:

1 (i) a record of, or plan to conform to, best practices including, but  
2 not limited to, clear policies for the resident business entities and  
3 graduation from the space;

4 (ii) a comprehensive suite of entrepreneurial mentoring practices  
5 including, but not limited to, advising, coaching, planning and connect-  
6 ing to funding and technology sources;

7 (iii) the capacity to secure substantial private and other non-state  
8 governmental funding for the proposed innovation hot spot, in addition  
9 to direct support from the sponsoring academic institution or related  
10 foundation;

11 (iv) the ability and willingness to cooperate with other local,  
12 regional and statewide economic development organizations, business  
13 support networks, venture and angel capital funding sources, and work-  
14 force development advocates;

15 (v) the capacity to collaborate with other businesses and industries  
16 individually; and

17 (vi) such other requirements as the department deems appropriate for  
18 the format, content and filing of applications for designation as inno-  
19 vation hot spots.

20 (b) The commissioner shall also establish criteria for the designation  
21 of innovation hot spots.

22 (c) After establishing such criteria, the commissioner shall approve  
23 and designate five innovation hot spots and their operators in fiscal  
24 year two thousand thirteen--two thousand fourteen and five additional  
25 innovation hot spots and their operators in fiscal year two thousand  
26 fourteen--two thousand fifteen.

1 (d) The commissioner shall issue a certificate of approval for each  
2 designated innovation hot spot and each approved operator of an inno-  
3 vation hot spot.

4 (e) The operator of an approved innovation hot spot may accept appli-  
5 cations for tenancies from qualified entities for a period of five years  
6 after the receipt by such innovation hot spot of its certificate of  
7 approval from the commissioner. Qualified entities that locate their  
8 businesses in an innovation hot spot are eligible to receive tax bene-  
9 fits under section thirty-eight of the tax law for five taxable years,  
10 beginning with the first taxable year during which such qualified enti-  
11 ties become tenants in an innovation hot spot.

12 4. Each operator of an innovation hot spot shall report on an annual  
13 basis on its activities to the commissioner in a manner and according to  
14 the schedule established by the department, and shall provide such addi-  
15 tional information as the commissioner may require. The commissioner  
16 shall evaluate the operations of the innovation hot spots using methods  
17 including but not limited to site visits, reports pursuant to specified  
18 information, and review evaluations. If the commissioner is unsatisfied  
19 with the progress of an operator of an innovation hot spot, the commis-  
20 sioner shall notify such operator of the results of its evaluations and  
21 the findings of deficiencies in the operation of such hot spot and shall  
22 allow and cooperate with such operator to remedy such findings in a  
23 timely manner.

24 5. Notwithstanding any provision of this chapter, employees and offi-  
25 cers of the department and the department of taxation and finance shall  
26 be allowed and are directed to share and exchange:



1 (i) information derived from tax returns or reports that is relevant  
2 to a qualified entity's eligibility to participate in the innovation hot  
3 spots program, and

4 (ii) information regarding the tax benefits applied for, allowed, or  
5 claimed pursuant to section thirty-eight of the tax law and the taxpay-  
6 ers who are applying for or are claiming the tax benefits.

7 All information exchanged between the department and the department of  
8 taxation and finance shall not be subject to disclosure or inspection  
9 pursuant to the state's freedom of information law. The department  
10 shall not disclose any information obtained from the department of taxa-  
11 tion and finance that concerns specific taxpayers.

12 § 3. The tax law is amended by adding a new section 38 to read as  
13 follows:

14 § 38. New York innovation hot spot program tax benefits. (a) As used  
15 in this chapter, the terms "innovation hot spot" and "qualified entity"  
16 shall have the same meaning as under section three hundred sixty-one of  
17 the economic development law.

18 (b) A taxpayer under article nine-A of this chapter that is a quali-  
19 fied entity and also a tenant in an innovation hot spot shall be subject  
20 only to the fixed dollar minimum tax, imposed under paragraph (d) of  
21 subdivision one of section two hundred ten of this chapter, for five  
22 taxable years, beginning with the first taxable year during which the  
23 qualified entity becomes a tenant in an innovation hot spot. A taxpayer  
24 under article nine-A of this chapter that is a corporate partner in a  
25 qualified entity, or is a qualified entity that is located both within  
26 and without an innovation hot spot, shall be allowed only a deduction  
27 for the amount of income or gain included in its federal adjusted gross  
28 income to the extent that the income or gain is attributable to the

1 operations at the innovation hot spot. The deduction is allowed for five  
2 taxable years, beginning with the first taxable year during which the  
3 qualified entity becomes a tenant in an innovation hot spot.

4 (c) An individual who is the sole proprietor of a qualified entity or  
5 a member of a limited liability company, a partner in a partnership or a  
6 shareholder in a New York subchapter S corporation where the limited  
7 liability company, partnership, or S corporation is a qualified entity,  
8 that is taxable under article twenty-two of this chapter shall be  
9 allowed a deduction for the amount of income or gain included in its  
10 federal adjusted gross income to the extent that the income or gain is  
11 attributable to the operations of a qualified entity which is a tenant  
12 in an innovation hot spot. The deduction is allowed for five taxable  
13 years, beginning with the first taxable year during which the qualified  
14 entity becomes a tenant in an innovation hot spot.

15 (d) A qualified entity that is a tenant in an innovation hot spot  
16 shall be eligible for a credit or refund for sales and use taxes imposed  
17 on the retail sale of tangible personal property or services under  
18 subdivisions (a), (b), and (c) of section eleven hundred five and  
19 section eleven hundred ten of this chapter. The credit or refund shall  
20 be allowed for sixty months beginning with the first full month after  
21 the qualified entity becomes a tenant in an innovation hot spot.

22 (e) A taxpayer who claims any of the tax benefits described in this  
23 section is no longer eligible for any other New York state exemptions,  
24 deductions, or credit or refunds under this chapter to the extent that  
25 any such exemption, deduction, credit or refund is attributable to the  
26 business operations of a tenant in an innovation hot spot. The election  
27 to claim the tax benefits described in this section is not revocable.

10 (18) the amount of income or gain included in federal adjusted gross  
11 income of a taxpayer that is a partner in a qualified entity or is a  
12 qualified entity that is located both within and without an innovation  
13 hot spot, to the extent that the income or gain is attributable to the  
14 operations of a qualified entity at the innovation hot spot as provided  
15 in section thirty-eight of this chapter.

16 § 5. Section 209 of the tax law is amended by adding a new subdivision  
17 11 to read as follows:

18 11. Except as provided in subparagraph eighteen of paragraph (a) of  
19 subdivision nine of section two hundred eight of this article, a corpo-  
20 ration that is a qualified entity and also a tenant in an innovation hot  
21 spot shall be subject only to the fixed dollar minimum tax under para-  
22 graph (d) of subdivision one of section two hundred ten of this article,  
23 as provided in section thirty-eight of this chapter.

24 § 6. Subsection (c) of section 612 of the tax law is amended by adding  
25 a new paragraph 39 to read as follows:

26 (39) Any income or gain, to the extent it is included in federal  
27 adjusted gross income of an individual who is the sole proprietor of a  
28 qualified entity or a member of a limited liability company, a partner

1 in a partnership or a shareholder in a New York subchapter S corporation  
2 that is a qualified entity, attributable to the operations of a quali-  
3 fied entity at its location in an innovation hot spot, as provided in  
4 section thirty-eight of this chapter.

5 § 7. Paragraph 1 of subdivision (d) of section 1119 of the tax law, as  
6 added by section 31 of part S-1 of chapter 57 of the laws of 2009, is  
7 amended to read as follows:

8 (1) Subject to the conditions and limitations provided for in this  
9 section, a refund or credit will be allowed for taxes imposed on the  
10 retail sale of tangible personal property described in subdivision (a)  
11 of section eleven hundred five of this article, and on every sale of  
12 services described in subdivisions (b) and (c) of such section, and  
13 consideration given or contracted to be given for, or for the use of,  
14 such tangible personal property or services, where such tangible  
15 personal property or services are sold to a qualified empire zone enter-  
16 prise or to a qualified entity that is also a tenant in an innovation

5 place of primary use of the service described in paragraph two of such  
6 subdivision (b) of section eleven hundred five is at an address in such  
7 empire zone or at an innovation hot spot; provided, further, that, in  
8 order for a motor vehicle, as defined in subdivision (c) of section  
9 eleven hundred seventeen of this article, or tangible personal property  
10 related to such a motor vehicle to be found to be used predominantly in  
11 such a zone, at least fifty percent of such motor vehicle's use shall be  
12 exclusively within such zone or at least fifty percent of such motor

4 the city of New York, as added by section 7 of part HH of chapter 57 of  
5 the laws of 2010, is amended to read as follows:

6 (g) (1) With respect to an individual whose New York adjusted gross  
7 income is over one million dollars but no more than ten million dollars,  
8 the New York itemized deduction shall be an amount equal to fifty  
9 percent of any charitable contribution deduction allowed under section  
10 one hundred seventy of the internal revenue code for taxable years  
11 beginning after two thousand nine and before two thousand [thirteen]  
12 sixteen. With respect to an individual whose New York adjusted gross  
13 income is over one million dollars, the New York itemized deduction  
14 shall be an amount equal to fifty percent of any charitable contribution  
15 deduction allowed under section one hundred seventy of the internal

7 (o) Related members expense add back [and income exclusion]. (1) Defi-  
8 nitions. (A) Related member [or members. For purposes of this paragraph,  
9 the term related member or members means a person, corporation, or other  
10 entity, including an entity that is treated as a partnership or other  
11 pass-through vehicle for purposes of federal taxation, whether such  
12 person, corporation or entity is a taxpayer or not, where one such  
13 person, corporation, or entity, or set of related persons, corporations  
14 or entities, directly or indirectly owns or controls a controlling

24 patents and any other similar types of intangible assets as determined

19 (B) [The add back of royalty payments shall not be required if and to  
20 the extent that such payments meet either of the following conditions:

21 (i) the related member during the same taxable year directly or indi-

23 related member, and such transaction was done for a valid business  
24 purpose and the payments are made at arm's length;

25 (ii) the royalty payments are paid or incurred to a related member

2 equal to that imposed by this state.

3 (3) Royalty income exclusions. For the purpose of computing entire net  
4 income or other taxable basis, a taxpayer shall be allowed to deduct  
5 royalty payments directly or indirectly received from a related member  
6 during the taxable year to the extent included in the taxpayer's federal  
7 taxable income unless such royalty payments would not be required to be  
8 added back under subparagraph two of this paragraph or other similar

20 between the taxpayer and the related member was undertaken for a valid

22 (ii) The adjustment required in this paragraph shall not apply if the  
23 taxpayer establishes, by clear and convincing evidence of the type and  
24 in the form specified by the commissioner, that: (I) the related member  
25 was subject to tax on or measured by its net income in this state or  
26 another state or possession of the United States or some combination  
27 thereof; (II) the tax base for said tax included the royalty payment  
28 paid, accrued or incurred by the taxpayer; and (III) the aggregate

1 effective rate of tax applied to the related member in those jurisdic-  
2 tions is no less than eighty percent of the statutory rate of tax that  
3 applied to the taxpayer under section two hundred ten of this article  
4 for the taxable year.

5 (iii) The adjustment required in this paragraph shall not apply if the  
6 taxpayer establishes, by clear and convincing evidence of the type and  
7 in the form specified by the commissioner, that: (I) the royalty payment  
8 was paid, accrued or incurred to a related member organized under the  
9 laws of a country other than the United States; (II) the related  
10 member's income from the transaction was subject to a comprehensive  
11 income tax treaty between such country and the United States; (III) the  
12 related member was subject to tax in a foreign nation on a tax base that  
13 included the royalty payment paid, accrued or incurred by the taxpayer;  
14 (IV) the related member's income from the transaction was taxed in such  
15 country at an effective rate of tax at least equal to that imposed by  
16 this state; and (V) the royalty payment was paid, accrued or incurred  
17 pursuant to a transaction that was undertaken for a valid business  
18 purpose and using terms that reflect an arm's length relationship.

5 (B) Royalty expense add backs. (i) For the purpose of computing New  
6 York unrelated business taxable income, a taxpayer must add back royalty  
7 payments [to a] directly or indirectly paid, accrued, or incurred in  
8 connection with one or more direct or indirect transactions with one or  
9 more related [member] members during the taxable year to the extent  
10 deductible in calculating federal unrelated business taxable income;

11 (ii) [The add back of royalty payments shall not be required if and to  
12 the extent that such payments meet either of the following conditions:

13 (I) the related member during the same taxable year directly or indi-  
14 rectly paid or incurred the amount to a person or entity that is not a  
15 related member, and such transaction was done for a valid business and  
16 the payments are made at arm's length;

17 (II) the royalty payments are paid or incurred to a related member  
18 organized under the laws of a country other than the United States, are

16 combined voting power of all classes of stock of such corporation, or  
17 thirty percent or more of the capital, profits or beneficial interest in  
18 such voting stock of such corporation, and (ii) in the case of a part-  
19 nership, association, trust or other entity, thirty percent or more of  
20 the capital, profits or beneficial interest in such partnership, associ-  
21 ation, trust or other entity.] Effective rate of tax. "Effective rate of  
22 tax" means, as to any city, the maximum statutory rate of tax imposed by  
23 the city on or measured by a related member's net income multiplied by  
24 the apportionment percentage, if any, applicable to the related member  
25 under the laws of said jurisdiction. For purposes of this definition,  
26 the effective rate of tax as to any city is zero where the related  
27 member's net income tax liability in said city is reported on a combined  
28 or consolidated return including both the taxpayer and the related

1 member where the reported transactions between the taxpayer and the  
2 related member are eliminated or offset. Also, for purposes of this  
3 definition, when computing the effective rate of tax for a city in which  
4 a related member's net income is eliminated or offset by a credit or  
5 similar adjustment that is dependent upon the related member either  
6 maintaining or managing intangible property or collecting interest  
7 income in that city, the maximum statutory rate of tax imposed by said  
8 city shall be decreased to reflect the statutory rate of tax that  
9 applies to the related member as effectively reduced by such credit or  
10 similar adjustment.

11 (C) Royalty payments. Royalty payments are payments directly connected  
12 to the acquisition, use, maintenance or management, ownership, sale,  
13 exchange, or any other disposition of licenses, trademarks, copyrights,  
14 trade names, trade dress, service marks, mask works, trade secrets,  
15 patents and any other similar types of intangible assets as determined  
16 by the state commissioner of taxation and finance, and [includes]  
17 include amounts allowable as interest deductions under section one  
18 hundred sixty-three of the internal revenue code to the extent such  
19 amounts are directly or indirectly for, related to or in connection with  
20 the acquisition, use, maintenance or management, ownership, sale,  
21 exchange or disposition of such intangible assets.

22 (D) Valid business purpose. A valid business purpose is one or more  
23 business purposes, other than the avoidance or reduction of taxation,  
24 which alone or in combination constitute the primary motivation for some  
25 business activity or transaction, which activity or transaction changes  
26 in a meaningful way, apart from tax effects, the economic position of  
27 the taxpayer. The economic position of the taxpayer includes an increase

1 in the market share of the taxpayer, or the entry by the taxpayer into  
2 new business markets.

3 (2) Royalty expense add backs. (A) For the purpose of computing city  
4 adjusted gross income, a taxpayer must add back royalty payments [to a]  
5 directly or indirectly paid, accrued, or incurred in connection with one  
6 or more direct or indirect transactions with one or more related  
7 [member] members during the taxable year to the extent deductible in  
8 calculating federal taxable income.

9 (B) [The add back of royalty payments shall not be required if and to  
10 the extent that such payments meet either of the following conditions:

11 (i) the related member during the same taxable year directly or indi-  
12 rectly paid or incurred the amount to a person or entity that is not a  
13 related member, and such transaction was done for a valid business and  
14 the payments are made at arm's length;

15 (ii) the royalty payments are paid or incurred to a related member  
16 organized under the laws of a country other than the United States, are  
17 subject to a comprehensive income tax treaty between such country and  
18 the United States, and are taxed in such country at a tax rate at least  
19 equal to that imposed by this state.

20 (3) Royalty income exclusions. (A) For the purpose of computing city  
21 adjusted gross income, a taxpayer shall be allowed to deduct royalty  
22 payments directly or indirectly received from a related member during  
23 the taxable year to the extent included in the taxpayer's federal taxa-  
24 ble income unless such royalty payments would not be required to be  
25 added back under paragraph two of this subdivision or other similar  
26 provision in this title.] Exceptions. (i) The adjustment required in  
27 this subdivision shall not apply to the portion of the royalty payment  
28 that the taxpayer establishes, by clear and convincing evidence of the



1 type and in the form specified by the commissioner of finance, meets all  
2 of the following requirements: (I) the related member was subject to tax  
3 in this city or another city within the United States or a foreign

26 ized under the laws of a country other than the United States; (II) the

1 the related member was subject to tax in a foreign nation on a tax base  
2 that included the royalty payment paid, accrued or incurred by the  
3 taxpayer; (IV) the related member's income from the transaction was  
4 taxed in such country at an effective rate of tax at least equal to that  
5 imposed by this city; and (V) the royalty payment was paid, accrued or  
6 incurred pursuant to a transaction that was undertaken for a valid busi-  
7 ness purpose and using terms that reflect an arm's length relationship.

8 (iv) The adjustment required in this subdivision shall not apply if  
9 the taxpayer and the commissioner of finance agree in writing to the  
10 application or use of alternative adjustments or computations. The  
11 commissioner of finance may, in his or her discretion, agree to the  
12 application or use of alternative adjustments or computations when he or  
13 she concludes that in the absence of such agreement the income of the  
14 taxpayer would not be properly reflected.

2 part W-1 of chapter 109 of the laws of 2006, is amended to read as

4 § 187-b. [Alternative fuels credit] Electric vehicle recharging prop-  
5 erty credit. 1. General. A taxpayer shall be allowed a credit, to be  
6 credited against the taxes imposed under sections one hundred eighty-  
7 three, one hundred eighty-four, and one hundred eighty-five of this  
8 article. Such credit, to be computed as hereinafter provided, shall be  
9 allowed for [alternative fuel vehicle refueling] electric vehicle  
10 recharging property placed in service during the taxable year. Provided,  
11 however, that the amount of such credit allowable against the tax  
12 imposed by section one hundred eighty-four of this article shall be the  
13 excess of the credit allowed by this section over the amount of such  
14 credit allowable against the tax imposed by section one hundred eighty-  
15 three of this article.

16 2. [Alternative fuel vehicle refueling property] Electric vehicle  
17 recharging property. The credit under this section for [alternative  
18 fuel vehicle refueling] electric vehicle recharging property shall equal  
19 for each installation of property the lesser of five thousand dollars or  
20 fifty percent of the cost of any such property:

21 (a) which is located in this state; [and]

22 (b) [for which a credit is allowed under section thirty C of the

4 3. Definitions. [(a)] The term ["alternative fuel vehicle refueling  
5 property"] "electric vehicle recharging property" means [any such prop-  
6 erty which is qualified within the meaning of section thirty C of the  
7 internal revenue code, but shall not include alternative fuel vehicle  
8 refueling property relating to a qualified hybrid vehicle as such vehi-  
9 cle is defined in subparagraph (B) of paragraph three of subsection (p)  
10 of section six hundred six of this chapter] all the equipment needed to  
11 convey electric power from the electric grid or another power source to  
12 an onboard vehicle energy storage system.

13 [(b) The term "qualified hybrid vehicle" shall have the same meaning  
14 as provided for under subparagraph (B) of paragraph three of subsection  
15 (p) of section six hundred six of this chapter.]

16 4. Carryovers. In no event shall the credit under this section be  
17 allowed in an amount which will reduce the tax payable to less than the  
18 applicable minimum tax fixed by section one hundred eighty-three or one  
19 hundred eighty-five of this article. If, however, the amount of credit  
20 allowable under this section for any taxable year reduces the tax to  
21 such amount, any amount of credit not deductible in such taxable year  
22 may be carried over to the following year or years and may be deducted  
23 from the taxpayer's tax for such year or years.

24 5. Credit recapture[; Alternative fuel vehicle refueling property].  
25 If, at any time before the end of its recovery period, [alternative fuel  
26 vehicle refueling] electric vehicle recharging property ceases to be  
27 qualified, a recapture amount must be added back in the year in which  
28 such cessation occurs.

1 (i) Cessation of qualification. [Alternative fuel vehicle refueling  
2 property] Electric vehicle recharging property ceases to be qualified  
3 if:

4 (I) the property no longer qualifies as [property described in section  
5 thirty C of the internal revenue code] electric vehicle recharging prop-  
6 erty; or

7 (II) fifty percent or more of the use of the property in a taxable  
8 year is other than a trade or business in this state; or

9 (III) the taxpayer receiving the credit under this section sells or  
10 disposes of the property and knows or has reason to know that the prop-  
11 erty will be used in a manner described in this subparagraph.

12 (ii) Recapture amount. The recapture amount is equal to the credit  
13 allowable under this section multiplied by a fraction, the numerator of  
14 which is the total recovery period for the property minus the number of  
15 recovery years prior to, but not including, the recapture year, and the  
16 denominator of which is the total recovery period.

17 6. Termination. The credit allowed by subdivision two of this section  
18 shall not apply in taxable years beginning after December thirty-first,  
19 two thousand [ten] seventeen.

20 § 2. Subdivision 24 of section 210 of the tax law, as amended by  
21 section 15 of part W-1 of chapter 109 of the laws of 2006, is amended to  
22 read as follows:

23 24. [Alternative fuels] Electric vehicle recharging property credit.

24 (a) General. A taxpayer shall be allowed a credit, to be computed as  
25 hereinafter provided, against the tax imposed by this article for  
26 [alternative fuel vehicle refueling] electric vehicle recharging proper-  
27 ty placed in service during the taxable year.

1 (b) [Alternative fuel vehicle refueling property] Electric vehicle  
2 recharging property. The credit under this subdivision for [alternative  
3 fuel vehicle refueling] electric vehicle recharging property shall equal  
4 for each installation of property the lesser of five thousand dollars or  
5 fifty percent of the cost of any such property:

6 (i) which is located in this state; [and]

7 (ii) [for which a credit is allowed under section thirty C of the  
8 internal revenue code but not including alternative fuel refueling prop-  
9 erty relating to a qualified hybrid vehicle as such vehicle is defined  
10 in subparagraph (B) of paragraph three of subsection (p) of section six  
11 hundred six of this chapter] which is electric vehicle recharging prop-  
12 erty; and

13 (iii) for which none of the cost has been paid for from the proceeds  
14 of grants, including grants from the New York state energy research and  
15 development authority or the New York power authority.

16 (c) Definitions. The term ["alternative fuel vehicle refueling proper-  
17 ty"] "electric vehicle recharging property" means [any such property  
18 which is qualified within the meaning of section thirty C of the inter-  
19 nal revenue code but shall not include alternative fuel vehicle refuel-  
20 ing property relating to a qualified hybrid vehicle as such vehicle is  
21 defined in subparagraph (B) of paragraph three of subsection (p) of  
22 section six hundred six of this chapter] all of the equipment needed to  
23 convey electric power from the electric grid or another power source to  
24 an onboard vehicle energy storage system.

25 (d) Carryovers. In no event shall the credit under this subdivision be  
26 allowed in an amount which will reduce the tax payable to less than the  
27 higher of the amounts prescribed in paragraphs (c) and (d) of subdivi-  
28 sion one of this section. Provided, however, that if the amount of cred-

1 it allowable under this subdivision for any taxable year reduces the tax  
2 to such amount, any amount of credit not deductible in such taxable year  
3 may be carried over to the following year or years and may be deducted  
4 from the taxpayer's tax for such year or years.

5 (e) Credit recapture. [(i) Alternative fuel vehicle refueling proper-  
6 ty.] If, at any time before the end of its recovery period, [alternative  
7 fuel vehicle refueling] electric vehicle recharging property ceases to  
8 be qualified, a recapture amount must be added back in the year in which  
9 such cessation occurs.

10 (A) [Alternative fuel vehicle refueling] Electric vehicle recharging  
11 property ceases to be qualified if:

12 (1) the property no longer qualifies as [property described in section  
13 thirty C of the internal revenue code] electric vehicle recharging prop-  
14 erty; or

15 (2) fifty percent or more of the use of the property in a taxable year  
16 is other than in a trade or business in this state; or

17 (3) the taxpayer receiving the credit under this subdivision sells or  
18 disposes of the property and knows or has reason to know that the prop-  
19 erty will be used in a manner described in clauses one and two of this  
20 subparagraph.

21 (B) Recapture amount. The recapture amount is equal to the credit  
22 allowable under this subdivision multiplied by a fraction, the numerator  
23 of which is the total recovery period for the property minus the number  
24 of recovery years prior to, but not including, the recapture year, and  
25 the denominator of which is the total recovery period.

26 [(f) Affiliates. (i) If a credit under this subdivision is allowed to  
27 a taxpayer with respect to a taxable year, the action taken by such  
28 taxpayer which resulted in such credit being allowed thereto may, at the

1 election of the taxpayer and an affiliate thereof, be ascribed to such  
2 affiliate. Where such affiliate, based on such ascription, is allowed  
3 such credit and deducts from the tax otherwise due the amount of such  
4 credit, such credit shall be deemed in all respects to have been allowed  
5 to such affiliate, provided that any action or inaction by the taxpayer  
6 which constitutes an event of recapture described in paragraph (e) of  
7 this subdivision shall be ascribed to the affiliate and shall constitute  
8 an event of recapture with respect to the credit allowed to the affil-  
9 iate pursuant to this subdivision.

10 (ii) Notwithstanding any other provision of law to the contrary, in  
11 the case of the credit provided for under this subdivision being allowed  
12 to, or asserted to be allowed to, an affiliate, pursuant to subparagraph  
13 (i) of this paragraph, the commissioner shall have the same powers with  
14 respect to examining the books and records of the taxpayer, and have  
15 such other powers of investigation with respect to the taxpayer, as are  
16 afforded under this chapter with respect to a taxpayer which has  
17 deducted the credit allowed under this section from tax otherwise due,  
18 as if it were the taxpayer which had deducted such credit from tax  
19 otherwise due.

20 (iii) The term "affiliate" shall mean a corporation substantially all  
21 the capital stock of which is owned or controlled either directly or  
22 indirectly by the taxpayer, or which owns or controls either directly or  
23 indirectly substantially all the capital stock of the taxpayer, or  
24 substantially all the capital stock of which is owned or controlled  
25 either directly or indirectly by interests which own or control either  
26 directly or indirectly substantially all the capital stock of the  
27 taxpayer.]

1 [(g)] (f) Termination. The credit allowed by paragraph (b) of this  
2 subdivision shall not apply in taxable years beginning after December  
3 thirty-first, two thousand [ten] seventeen.

4 § 3. Subsection (p) of section 606 of the tax law, as amended by  
5 section 16 of part W-1 of chapter 109 of the laws of 2006, is amended to  
6 read as follows:

7 (p) [Alternative fuels] Electric vehicle recharging property credit.

8 (1) General. A taxpayer shall be allowed a credit, to be computed as  
9 hereinafter provided, against the tax imposed by this article, for  
10 [alternative fuel vehicle refueling] electric vehicle recharging proper-  
11 ty placed in service during the taxable year.

12 (2) [Alternative fuel vehicle refueling property] Electric vehicle  
13 recharging property. The credit under this subsection for [clean-fuel  
14 vehicle refueling] electric vehicle recharging property shall equal for  
15 each installation of property the lesser of five thousand dollars or  
16 fifty percent of the cost of any such property

17 (A) which is located in this state [and];

18 (B) [for which a credit is allowed under section thirty C of the  
19 internal revenue code but not including alternative fuel vehicle refuel-  
20 ing property relating to a qualified hybrid vehicle as such vehicle is  
21 defined in subparagraph (B) of paragraph three of this subsection] which  
22 is electric vehicle recharging property; and

23 (C) for which none of the cost has been paid for from the proceeds of  
24 grants, including grants from the New York state energy research and  
25 development authority or the New York power authority.

26 (3) Definitions. [(A)] The term ["alternative fuel vehicle refueling  
27 property"] "electric vehicle recharging property" means [any such prop-  
28 erty which is qualified within the meaning of section thirty C of the

1 internal revenue code, but such term shall not include alternative fuel  
2 vehicle refueling property relating to a qualified hybrid vehicle as  
3 such vehicle is defined in subparagraph (B) of this paragraph] all the  
4 equipment needed to convey electric power from the electric grid or  
5 another power source to an onboard vehicle energy storage system.

6 [(B) The term "qualified hybrid vehicle" means a motor vehicle, as  
7 defined in section one hundred twenty-five of the vehicle and traffic  
8 law,, that:

9 (i) draws propulsion energy from both

10 (a) an internal combustion engine (or heat engine that uses combusti-  
11 ble fuel); and

12 (b) an energy storage device; and

13 (ii) employs a regenerative vehicle braking system that recovers waste  
14 energy to charge such energy storage device.]

15 (4) Carryovers. If the amount of credit allowable under this  
16 subsection shall exceed the taxpayer's tax for such year, the excess may  
17 be carried over to the following year or years and may be deducted from  
18 the taxpayer's tax for such year or years.

19 (5) Credit recapture. (A) [Vehicles.

20 (i) If, within three full years from the date a qualified hybrid vehi-  
21 cle or a vehicle of which alternative fuel vehicle property is a part is  
22 placed in service, such qualified hybrid vehicle or vehicle of which  
23 alternative fuel vehicle property is a part] If, at any time before the  
24 end of its recovery period, electric vehicle recharging property ceases  
25 to be qualified, a recapture amount must be added back in the tax year  
26 in which such cessation occurs.

27 [(ii)] (B) Cessation of qualification. [(I) A qualified hybrid vehicle  
28 ceases to be qualified if



1 (a) it is modified by the taxpayer so that it no longer meets the  
2 requirements of a qualified hybrid vehicle as defined in subparagraph  
3 (B) of paragraph three of this subsection.

4 (b) the taxpayer receiving the credit under this subsection sells or  
5 disposes of the vehicle and knows or has reason to know that the vehicle  
6 will be so modified.

7 (B) Alternative fuel vehicle refueling property. (i) If, at any time  
8 before the end of its recovery period, alternative fuel vehicle refuel-  
9 ing property ceases to be qualified, a recapture amount must be added  
10 back in the year in which such cessation occurs.

11 (ii) Cessation of qualification. Clean-fuel vehicle refueling] Elec-  
12 tric vehicle recharging property ceases to be qualified if:

13 [(I)] (i) the property no longer qualifies as [property described in  
14 section thirty C of the internal revenue code] electric vehicle recharg-  
15 ing property, or

16 [(II)] (ii) fifty percent or more of the use of the property in a  
17 taxable year is other than in a trade or business in this state, or

18 [(III)] (iii) the taxpayer receiving the credit under this subsection  
19 sells or disposes of the property and knows or has reason to know that  
20 the property will be used in a manner described in [item (I)] clause (i)  
21 or [(II)] (ii) of this [clause] subparagraph.

22 [(iii)] (C) Recapture amount. The recapture amount is equal to the  
23 credit allowable under this subsection multiplied by a fraction, the  
24 numerator of which is the total recovery period for the property minus  
25 the number of recovery years prior to, but not including, the recapture  
26 year, and the denominator of which is the total recovery period.

1 (6) Termination. The credit allowed by [paragraph two of] this  
2 subsection shall not apply in taxable years beginning after December  
3 thirty-first, two thousand [ten] seventeen.

4 § 4. Clause (ix) of subparagraph (B) of paragraph 1 of subsection (i)  
5 of section 606 of the tax law, as amended by section 7 of part C-1 of  
6 chapter 57 of the laws of 2009, is amended to read as follows:

7 (ix) [Alternative fuels]	[Cost] <u>Amount of credit</u>
8 <u>Electric vehicle</u>	under subdivision twenty-four
9 <u>recharging property</u>	of section two hundred ten
10 credit under subsection (p)	

11 § 5. This act shall take effect immediately and shall apply to taxable  
12 years beginning on or after January 1, 2013 for property placed in  
13 service on or after such date.

17 Section 1. Legislative intent. The legislature seeks to demonstrate  
18 that the state of New York is open for business by promoting, attract-  
19 ing, and encouraging the development of business in the state. The  
20 legislature intends to encourage businesses to locate in the state and  
21 produce goods and services within the state, thereby increasing job  
22 creation and economic growth. The legislature further intends to foster  
23 economic development by showcasing various goods that are produced in  
24 New York. In order to accomplish these objectives, the legislature  
25 intends that there shall be established "Taste-NY facilities," which  
26 will sell a variety of products, including but not limited to products

1 produced within the state, and prominently feature New York produced  
2 goods, including alcoholic beverages.

3 § 2. Subdivision (b) of section 1101 of the tax law is amended by  
4 adding a new paragraph 39 to read as follows:

5 (39) Taste-NY facility. "Taste-NY facility" shall mean a facility  
6 operated by a person designated by and pursuant to a written agreement  
7 with a state agency, public authority, or an interstate agency or public  
8 corporation created pursuant to an agreement or compact with another  
9 state or the Dominion of Canada, from which sales are made of tangible  
10 personal property or food and drink (whether or not for consumption on  
11 the premises of such facility), and that prominently features products  
12 produced within the state.

13 § 3. Subdivision (a) of section 1115 of the tax law is amended by  
14 adding a new paragraph 44 to read as follows:

15 (44) Tangible personal property sold at a Taste-NY facility, as  
16 defined in paragraph thirty-nine of section eleven hundred one of this  
17 article, for which the receipt or consideration given or contracted to  
18 be given is less than two hundred dollars per item.

19 § 4. Section 1115 of the tax law is amended by adding a new subdivi-  
20 sion (ii) to read as follows:

21 (ii) Receipts from sales of the following at a Taste-NY facility shall  
22 be exempt from the sales tax imposed under section eleven hundred five  
23 and the compensating use tax imposed under section eleven hundred ten of  
24 this article: (1) food or drink for consumption on the premises of such  
25 facility; (2) food or drink sold for consumption off the premises of  
26 such facility that is sold in a heated state; (3) sandwiches sold for  
27 consumption off the premises of such facility, whether or not sold in a  
28 heated state; (4) food or drink sold through vending machines; and (5)

1 food or drink sold in an unheated state that is of a type commonly sold  
2 for off-premises consumption and is not in the same form, condition,  
3 quantities and packaging as in establishments that are food stores other  
4 than those principally engaged in selling foods prepared and ready to be  
5 eaten.

6 § 5. The alcoholic beverage control law is amended by adding a new  
7 section 63-b to read as follows:

8 § 63-b. Special license to sell alcoholic beverages at retail for  
9 consumption off the premises. 1. Any person authorized to operate a  
10 Taste-NY facility designated by and pursuant to a written agreement with  
11 a state agency, public authority, or an interstate agency or public  
12 corporation created pursuant to an agreement or compact with another  
13 state or the Dominion of Canada may make application to the authority  
14 for a special license to sell alcoholic beverages at retail for consump-  
15 tion off the licensed premises.

16 2. An application for a license under this section shall be in such  
17 form and shall contain such information as shall be required by the  
18 authority and shall be accompanied by a check or draft in the amount  
19 required by this article.

20 3. Section fifty-four of this chapter shall control so far as is  
21 applicable the procedure in connection with such application.

22 4. A license under this section shall be issued to all eligible appli-  
23 cants except for good cause shown.

24 5. A license under this chapter shall not be subject to the provisions  
25 of subdivisions two, three, six and sixteen of section one hundred five  
26 of this chapter.

27 6. Notwithstanding the provisions of subdivision fourteen of section  
28 one hundred five of this chapter, the hours of operation and sale of

1 alcoholic beverages shall be governed by the licensee's written agree-  
2 ment with the state agency, public authority, interstate agency or  
3 compact entity.

4 7. Subject to any restriction contained in the written agreement with  
5 the state agency, public authority, interstate agency or compact entity,  
6 the holder of a license issued under this section may offer samples of  
7 alcoholic beverages to customers to be consumed on the licensed premises  
8 upon the following conditions:

9 (a) no fee shall be charged for any sample;

10 (b) each sample shall be limited:

11 (i) in the case of beer, wine products and cider, to three ounces or  
12 less;

13 (ii) in the case of wine, to two ounces;

14 (iii) in the case of liquor, to one-quarter ounce;

15 (c) no sample shall be provided to a customer during the hours prohib-  
16 ited by the provisions of subdivision five of section one hundred six of  
17 this chapter; and

18 (d) no customer may be provided with more than three samples in one  
19 calendar day.

20 § 6. Section 66 of the alcoholic beverage control law is amended by  
21 adding a new subdivision 11 to read as follows:

22 11. The annual fee for a special license to sell alcoholic beverages  
23 at retail for consumption off the licensed premises shall be five  
24 hundred dollars.

25 § 7. Section 67 of the alcoholic beverage control law, as amended by  
26 section 4 of part Z of chapter 85 of the laws of 2002, is amended to  
27 read as follows:

1 § 67. License fees, duration of licenses; fee for part of year.  
2 [Effective April first, nineteen hundred eighty-three, licenses] 1.  
3 Licenses issued pursuant to sections sixty-one, sixty-two, sixty-three,  
4 [sixty-four, sixty-four-a and sixty-four-b] and sixty-three-b of this  
5 article shall be effective for three years at three times that annual  
6 fee, except that, in implementing the purposes of this section, the  
7 liquor authority shall schedule the commencement dates, duration and  
8 expiration dates thereof to provide for an equal cycle of license  
9 renewals issued under each such section through the course of the fiscal  
10 year. [Effective December first, nineteen hundred ninety-eight,  
11 licenses]

12 2. Licenses issued pursuant to sections sixty-four, sixty-four-a and  
13 sixty-four-b of this article shall be effective for two years at two  
14 times that annual fee, except that, in implementing the purposes of this  
15 section, the liquor authority shall schedule the commencement dates,  
16 duration and expiration dates thereof to provide for an equal cycle of  
17 license renewals issued under each such section through the course of  
18 the fiscal year. [Notwithstanding the foregoing, commencing on December  
19 first, nineteen hundred ninety-eight and concluding on July thirty-  
20 first, two thousand two, a licensee issued a license pursuant to section  
21 sixty-four, sixty-four-a or sixty-four-b of this article may elect to  
22 remit the fee for such license in equal annual installments. Such  
23 installments shall be due on dates established by the liquor authority  
24 and the failure of a licensee to have remitted such annual installments  
25 after a due date shall be a violation of this chapter. For licenses  
26 issued for less than the three-year licensing period, the license fee  
27 shall be levied on a pro-rated basis.]



1     3. The entire license fee shall be due and payable at the time of  
2 application. The liquor authority may make such rules as shall be appro-  
3 priate to carry out the purpose of this section.

4     § 8. Subdivisions 1 and 2 of section 56-a of the alcoholic beverage  
5 control law, as amended by chapter 108 of the laws of 2012, are amended

24 sion four of section one hundred of this chapter, a filing fee of twenty  
25 dollars; and with each application for a permit under section ninety-

27 year basis, section ninety-seven, ninety-eight, ninety-nine, or ninety-  
28 nine-b of this chapter, other than a permit to be issued pursuant to

1 paragraph b, c, e or j of subdivision one of section ninety-nine-b of  
2 this chapter on a calendar year basis, a filing fee of ten dollars.

3 2. In addition to the annual fees provided for in this chapter, there  
4 shall be paid to the authority with each renewal application for a  
5 license filed pursuant to section fifty-one, fifty-one-a, fifty-three,  
6 fifty-eight, sixty-one, sixty-two, seventy-six or seventy-eight of this  
7 chapter, a filing fee of one hundred dollars; with each renewal applica-  
8 tion for a license filed pursuant to section sixty-three, sixty-three-b,  
9 sixty-four, sixty-four-a or sixty-four-b of this chapter, a filing fee  
10 of ninety dollars; with each renewal application for a license filed  
11 pursuant to section seventy-nine, eighty-one or eighty-one-a of this  
12 chapter, a filing fee of twenty-five dollars; and with each renewal  
13 application for a license or permit filed pursuant to section fifty-  
14 three-a, fifty-four, fifty-five, fifty-five-a, ninety-one, ninety-one-a,  
15 ninety-two, ninety-two-a, ninety-three, ninety-three-a, if such permit  
16 is issued on a calendar year basis, ninety-four, ninety-five, ninety-six  
17 or ninety-six-a of this chapter or pursuant to subdivisions b, c, e or j  
18 of section ninety-nine-b, if such permit is issued on a calendar year  
19 basis, or with each renewal application for an additional bar pursuant  
20 to subdivision four of section one hundred of this chapter, a filing fee  
21 of thirty dollars.

22 § 9. Paragraph (a) of subdivision 1 of section 101 of the alcoholic  
23 beverage control law, as amended by chapter 22 of the laws of 2011, is  
24 amended to read as follows:

25 (a) Be interested directly or indirectly in any premises where any  
26 alcoholic beverage is sold at retail; or in any business devoted wholly  
27 or partially to the sale of any alcoholic beverage at retail by stock  
28 ownership, interlocking directors, mortgage or lien or any personal or

1 real property, or by any other means. The provisions of this paragraph  
2 shall not apply to:

3 (i) any such premises or business constituting the overnight lodging  
4 and resort facility located wholly within the boundaries of the town of  
5 North Elba, county of Essex, township eleven, Richard's survey, great  
6 lot numbers two hundred seventy-eight, two hundred seventy-nine, two  
7 hundred eighty, two hundred ninety-eight, two hundred ninety-nine, three  
8 hundred, three hundred eighteen, three hundred nineteen, three hundred  
9 twenty, three hundred thirty-five and three hundred thirty-six, and  
10 township twelve, Thorn's survey, great lot numbers one hundred six and  
11 one hundred thirteen, as shown on the Adirondack map, compiled by the  
12 conservation department of the state of New York - nineteen hundred  
13 sixty-four edition, in the Essex county atlas at page twenty-seven in  
14 the Essex county clerk's office, Elizabethtown, New York, provided that  
15 such facility maintains not less than two hundred fifty rooms and suites  
16 for overnight lodging[,];

17 (ii) any such premises or business constituting the overnight lodging  
18 and resort facility located wholly within the boundaries of that tract  
19 or parcel of land situate in the city of Canandaigua, county of Ontario,  
20 beginning at a point in the northerly line of village lot nine where it  
21 meets with South Main Street, thence south sixty-nine degrees fifty-four  
22 minutes west a distance of nine hundred sixteen and twenty-three  
23 hundredths feet to an iron pin; thence in the same course a distance of  
24 fourteen feet to an iron pin; thence in the same course a distance of  
25 fourteen and four-tenths feet to a point; thence south fifteen degrees  
26 thirty-eight minutes and forty seconds east a distance of four hundred  
27 forty-six and eighty-seven hundredths feet to a point; thence south  
28 twenty-eight degrees thirty-seven minutes and fifty seconds east a

1 distance of one hundred thirteen and eighty-four hundredths feet to a  
2 point; thence south eighty-five degrees and forty-seven minutes east a  
3 distance of forty-seven and sixty-one hundredths feet to an iron pin;  
4 thence on the same course a distance of three hundred and sixty-five  
5 feet to an iron pin; thence north seventeen degrees twenty-one minutes  
6 and ten seconds east a distance of four hundred fifty-seven and thirty-  
7 two hundredths feet to an iron pin; thence north nineteen degrees and  
8 thirty minutes west a distance of two hundred and forty-eight feet to a  
9 point; thence north sixty-nine degrees and fifty-four minutes east a  
10 distance of two hundred eighty-four and twenty-six hundredths feet to a  
11 point; thence north nineteen degrees and thirty minutes west a distance  
12 of sixty feet to the point and place of beginning, provided that such  
13 facility maintains not less than one hundred twenty rooms and suites for  
14 overnight lodging[,,];

15 (iii) any such premises or business constituting the overnight lodging  
16 facility located wholly within the boundaries of that tract or parcel of  
17 land situated in the borough of Manhattan, city and county of New York,  
18 beginning at a point on the northerly side of west fifty-fourth street  
19 at a point one hundred feet easterly from the intersection of the said  
20 northerly side of west fifty-fourth street and the easterly side of  
21 seventh avenue; running thence northerly and parallel with the easterly  
22 side of seventh avenue one hundred feet five inches to the center line  
23 of the block; running thence easterly and parallel with the northerly  
24 side of west fifty-fourth street and along the center line of the block  
25 fifty feet to a point; running thence northerly and parallel with the  
26 easterly side of seventh avenue one hundred feet five inches to the  
27 southerly side of west fifty-fifth street at a point distant one hundred  
28 fifty feet easterly from the intersection of the said southerly side of

1 west fifty-fifth street and the easterly side of seventh avenue; running  
2 thence easterly along the southerly side of west fifty-fifth street  
3 thirty-one feet three inches to a point; running thence southerly and  
4 parallel with the easterly side of the seventh avenue one hundred feet  
5 five inches to the center line of the block; running thence easterly  
6 along the center line of the block and parallel with the southerly side  
7 of west fifty-fifth street, one hundred feet; running thence northerly  
8 and parallel with the easterly side of seventh avenue one hundred feet  
9 five inches to the southerly side of west fifty-fifth street; running

18 Northeast corner of lands belonging to Margaret Wexler and Donna Lee  
19 Wexler Pavlovic. Also all that tract or parcel of land commonly known  
20 as the Union Street School, located on the Northeasterly corner of Union  
21 and North College Streets in the First Ward of the City and County of  
22 Schenectady and State of New York, more particularly bounded and  
23 described as follows: Beginning at a point in the Northerly street line  
24 of Union Street where it is intersected by the Easterly street line of  
25 North College Street, and runs thence Northerly along the Easterly  
26 street line of North College Street, one hundred seven and five-tenths  
27 (107.5) feet to a point, thence easterly at an angle of ninety (90)  
28 degrees, one hundred ninety-one and seventy-five hundredths (191.75)

1 feet to a point in the Northwesterly street line of Erie Boulevard

3 vard, one hundred twenty-three and eight-tenths (123.8) feet to its  
4 intersection with the Northerly street line of Union Street; thence  
5 Westerly along the Northerly street line of Union Street, one hundred

8 The above described parcel of property includes the Blue Line parcel  
9 of land, which is a portion of the abandoned Erie Canal Lands, located  
10 in the First Ward of the City of Schenectady, New York, and which Blue  
11 Line parcel lies between the Northwesterly line of Erie Boulevard as set  
12 forth in the above described premises and the Northeasterly lot line of  
13 the old Union Street School as it runs parallel with the Northwesterly  
14 line of Erie Boulevard as aforesaid.

26 ning; [or (viii)]

27 (ix) any such premises or businesses located on that tract or parcel  
28 of land situate in the Town of Hopewell, Ontario County, State of New

1 York, bounded and described as follows: Commencing at a 5/8" rebar found  
2 on the division line between lands now or formerly of Ontario County -  
3 Finger Lakes Community College (Liber 698 of Deeds, Page 466) on the  
4 north and lands now or formerly of James W. Baird (Liber 768 of Deeds,  
5 Page 1109) on the south; thence, North 43°-33'-40" West, on said divi-  
6 sion line, a distance of 77.32 feet to the Point of Beginning. Thence,  
7 North 43°-33'-40" West, continuing on said division line and through  
8 said lands of Ontario County, a distance of 520.45 feet to a point on  
9 the southeasterly edge of an existing concrete pad; thence, South  
10 74°-19'-53" West, along said edge of concrete and the projection there-  
11 of, a distance of 198.78 feet to a point on the easterly edge of pave-  
12 ment of an existing campus drive; thence, the following two (2) courses  
13 and distances along said edge of pavement: Northeasterly on a curve to  
14 the left having a radius of 2221.65 feet, a chord bearing of North  
15 30°-16'-39" East, a chord distance of 280.79, a central angle of  
16 07°-14'-47", a length of 280.98 feet to a point of reverse curvature;  
17 thence, Northeasterly on a curve to the right having a radius of 843.42

19 534.08, a central angle of 36°-55'-01", a length of 543.43 feet to a  
20 point; thence, South 30°-04'-59" East, a distance of 18.28 feet to the  
21 corner of the property acquired by Ontario County (Liber 766 of Deeds,  
22 Page 1112), as shown on a map recorded in the Ontario County Clerk's  
23 Office as Map No. 6313; thence, the following four (4) courses and  
24 distances along said property line: South 30°-04'-59" East, a distance  
25 of 177.17 feet to a point; thence, South 02°-20'-33" East, a distance of  
26 147.53 feet to a point; thence, South 41°-31'-35" East, a distance of  
27 200.93 feet to a point; thence, South 23°-48'-53" West, along said prop-  
28 erty line, and the projection thereof, through the first said lands of

1 Ontario County - Finger Lakes Community College (Liber 698 of Deeds,  
2 Page 466), a distance of 517.96 feet to Point of Beginning. Said parcel  
3 containing 7.834 acres, more or less, as shown on a map entitled  
4 "Proposed Lease Area - Friends of the Finger Lakes Performing Arts  
5 Center, Hopewell, NY", prepared by Bergmann Associates, drawing LM-01,  
6 dated June 10, 2005, last revised August 17, 2005. The related PAC Prop-  
7 erties are shown on the Map denominated "FLCC Campus Property, FLPC  
8 Ground Lease, Parking, Vehicular & Pedestrian Access", recorded in the  
9 Ontario County Clerk's Office on December 10, 2009 in Book 1237 of Deeds  
10 at page 9 and are comprised of the areas separately labeled as Parking  
11 Lot 'A', Parking Lot 'G', the Ticket Booth area, the Sidewalks, and the  
12 Entry Roads[.];

13 (x) any premises licensed pursuant to section sixty-three-b of this  
14 chapter.

15 [The provisions of this paragraph shall not apply to] (xi) any prem-  
16 ises licensed under section sixty-four of this chapter in which a  
17 manufacturer or wholesaler holds a direct or indirect interest, provided  
18 that: [(I)] (1) said premises consist of an interactive entertainment  
19 facility which predominantly offers interactive computer and video  
20 entertainment attractions, and other games and also offers themed  
21 merchandise and food and beverages, [(II)] (2) the sale of alcoholic  
22 beverages within the premises shall be restricted to an area consisting  
23 of not more than twenty-five percent of the total interior floor area of  
24 the premises, [(III)] (3) the retail licenses shall derive not less than  
25 sixty-five percent of the total revenue generated by the facility from  
26 interactive video entertainment activities and other games, including  
27 related attractions and sales of merchandise other than food and alco-  
28 holic beverages, [(IV)] (4) the interested manufacturer or wholesaler,

1 or its parent company, shall be listed on a national securities exchange  
2 and its direct or indirect equity interest in the retail licensee shall  
3 not exceed twenty-five percent, [(V)] (5) no more than fifteen percent  
4 of said licensee's purchases of alcoholic beverages for sale in the  
5 premises shall be products produced or distributed by the manufacturer  
6 or wholesaler, [(VI)] (6) neither the name of the manufacturer or whole-  
7 saler nor the name of any brand of alcoholic beverage produced or  
8 distributed by said manufacturer or wholesaler shall be part of the name  
9 of the premises, [(VII)] (7) the name of the manufacturer or wholesaler  
10 or the name of products sold or distributed by such manufacturer or  
11 wholesaler shall not be identified on signage affixed to either the  
12 interior or the exterior of the premises in any fashion, [(VIII)] (8)  
13 promotions involving alcoholic beverages produced or distributed by the  
14 manufacturer or wholesaler are not held in such premises and further,  
15 retail and consumer advertising specialties bearing the name of the  
16 manufacturer or wholesaler or the name of alcoholic beverages produced  
17 or distributed by the manufacturer or wholesaler are not utilized in any  
18 fashion, given away or sold in said premises, and [(IX)] (9) except to  
19 the extent provided in this paragraph, the licensing of each premises  
20 covered by this exception is subject to all provisions of section  
21 sixty-four of this chapter, including but not limited to liquor authori-  
22 ty approval of the specific location thereof.

23 The provisions of this paragraph shall not prohibit (1) a manufacturer  
24 or wholesaler, if an individual, or a partner, of a partnership, or, if  
25 a corporation, an officer or director thereof, from being an officer or  
26 director of a duly licensed charitable organization which is the holder  
27 of a license for on-premises consumption under this chapter, nor (2) a  
28 manufacturer from acquiring any such premises if the liquor authority

1 first consents thereto after determining, upon such proofs as it shall  
2 deem sufficient, that such premises is contiguous to the licensed prem-  
3 ises of such manufacturer, and is reasonably necessary for the expansion  
4 of the facilities of such manufacturer. After any such acquisition, it  
5 shall be illegal for a manufacturer acquiring any such premises to sell  
6 or deliver alcoholic beverages manufactured by him to any licensee occu-  
7 pying such premises.

8 § 10. If any provision of this act or the application thereof shall  
9 for any reason be finally adjudged by a court of competent jurisdiction  
10 to be invalid or unconstitutional, such judgment shall not affect,  
11 impair, or invalidate the remainder of this act but shall be confined in  
12 its operation to the provision or provisions directly involved in the  
13 controversy in which such judgment shall have been rendered. It is here-  
14 by declared to be the intent of the legislature that this act would have  
15 been enacted even if such invalid provision or provisions had not been  
16 included. In the event that any provision of the laws of New York, as  
17 amended by this act, shall be finally adjudged by a court of competent  
18 jurisdiction to be invalid or unconstitutional, the provisions of such  
19 laws in effect prior to the date this act shall have become law shall  
20 not be affected by such judgment.

21 § 11. This act shall take effect immediately; provided, however, that  
22 the sales tax exemptions created by sections three and four of this act  
23 shall take effect on the first day of a sales tax quarterly period, as  
24 described in subdivision (b) of section 1136 of the tax law, next  
25 commencing at least 30 days after this act shall have become a law and  
26 shall apply in accordance with the applicable transitional provisions in  
27 sections 1106 and 1217 of the tax law; and provided further that the  
28 amendments to subdivisions 1 and 2 of section 56-a of the alcoholic

1 beverage control law made by section eight of this act shall take effect  
2 on the same date and in the same manner as sections 7 and 8, respective-  
3 ly, of chapter 108 of the laws of 2012, as amended, take effect.

4 PART J

5 Section 1. The general municipal law is amended by adding a new  
6 section 875 to read as follows:

7 § 875. Special provisions applicable to state sales and compensating  
8 use taxes and certain types of facilities. 1. For purposes of this  
9 section: "state sales and use taxes" means sales and compensating use  
10 taxes and fees imposed by article twenty-eight or twenty-eight-A of the  
11 tax law but excluding such taxes imposed in a city by section eleven  
12 hundred seven or eleven hundred eight of such article twenty-eight.  
13 "IDA" means an industrial development agency established by this article  
14 or an industrial development authority created by the public authorities  
15 law. "Commissioner" means the commissioner of taxation and finance.

16 2. (a) An IDA shall not provide state sales and use tax exemption  
17 benefits with respect to any project unless and until the prerequisites  
18 set forth in paragraphs (b), (c), (d) and (e) of this subdivision are  
19 met.

20 (b) Either (i) the agent or project operator of such project must have  
21 been certified as a participant in the excelsior jobs program, as such  
22 term "participant" is defined in section three hundred fifty-two of the  
23 economic development law, and provides to the IDA valid proof of partic-  
24 ipation in such program, or (ii) if such agent or project operator is  
25 not a participant in such program, the IDA, after reviewing the facts on  
26 the record, must find that the agent or project operator is a business

1 entity of the type described in subdivision one of section three hundred  
2 fifty-three of the economic development law and regulations adopted  
3 pursuant to such section.

4 (c) If the prerequisite in either subparagraph (i) or (ii) of para-  
5 graph (b) of this subdivision has been met, the IDA shall submit in  
6 writing its plan to provide such state sales and use tax exemption bene-  
7 fits for such project, together with the findings it made under such  
8 subparagraph (ii) of paragraph (b) to the commissioner of economic  
9 development.

10 (d) The commissioner of economic development shall review such  
11 proposed state sales and use tax exemption benefit plan for such project  
12 and determine, in consultation with the regional economic development  
13 council established by the governor that encompasses the jurisdiction  
14 for whose benefit the IDA recommending the tax exemption benefits was  
15 created, whether such proposed state sales and use tax exemption benefit  
16 plan for such project is consistent with regional economic development  
17 strategies.

18 (e) The commissioner of economic development shall review the IDA's  
19 findings, if any, and approve or disapprove the proposed benefits or  
20 deny them if such commissioner does not approve such IDA's findings that  
21 the agent/project operator is a business entity of the type required.  
22 Such commissioner is also authorized to modify the IDA's proposed plan  
23 by reducing the total amount of any such state sales and use tax  
24 exemption benefits or by specifying that such benefits shall apply to  
25 only some of the types of property or services proposed to be exempt  
26 from such state taxes or by reducing the time period during which such  
27 benefits may be provided. Such commissioner shall advise the IDA in  
28 writing of his or her approval, disapproval, denial, or modification of



1 the IDA's plan, and such approval, disapproval, denial, or modification  
2 shall bind the IDA as to whether the IDA can provide state sales and use  
3 tax exemption benefits and, if approved in whole or as modified, the  
4 amount of state sales and use tax exemption benefits that the IDA can  
5 provide with respect to such project, the types of property and services  
6 that may be eligible for exemption, and the duration of time during  
7 which such exemption benefits may apply. However, the IDA may provide  
8 state sales and use tax exemption benefits in a lesser amount, for fewer  
9 types of property or services, or for a shorter period, than as approved  
10 by such commissioner.

11 (f) Notwithstanding the foregoing, if at the time an IDA proposes a  
12 state sales and use tax exemption benefit plan there is no regional  
13 economic development council in the applicable region, then the commis-  
14 sioner of economic development shall review such plan and any such find-  
15 ings as provided in paragraph (d) of this subdivision, without regard to  
16 the recommendation of any other body.

17 (g) An IDA shall not provide state sales and use tax exemption bene-  
18 fits in an amount greater, for property or services other, or for a time  
19 period longer than as approved by the commissioner of economic develop-  
20 ment. Any amount of state sales and use tax exemption benefits that an  
21 IDA purports to provide in excess of the amount approved, or for differ-  
22 ent property or services than approved, or for a period longer than  
23 approved by such commissioner shall be void from its inception, and an  
24 agent, project operator, or other person or entity that makes a purchase  
25 or use without paying state sales and use taxes, or who paid such taxes  
26 but obtained a refund or credit of them, as a result shall be required  
27 to pay such amount of tax to the commissioner of taxation and finance in  
28 accordance with articles twenty-eight and twenty-nine of the tax law.

1 The commissioner shall be authorized to determine and assess state sales  
2 and use taxes foregone on account of an agent, project operator or other  
3 person or entity not having paid such state sales or use tax that should  
4 have been paid, or who obtained such a refund or credit but should not  
5 have, in accord with the applicable provisions of the tax law, except  
6 that any statute that limits the time by which the commissioner must  
7 determine or assess such tax shall not begin to run until the commis-  
8 sioner has received actual notice of such improper purchases or uses.

9 3. An IDA shall keep records of the amount of state and local sales  
10 and use tax exemption benefits provided to each project and each agent  
11 or project operator, and shall make such records available to the  
12 commissioner and state comptroller upon request. Such IDA shall also,  
13 within thirty days of providing financial assistance to a project that  
14 includes any amount of state sales and use tax exemption benefits,  
15 report to the commissioner and the state comptroller the amount of such  
16 benefits for such project, the project to which they are being provided,  
17 any limitation on the application or exercise of such exemptions, the  
18 types of property and services to be exempted, the time during which  
19 such exemption benefits apply, and the name and address of the agent or  
20 project operator of such project, together with such other information  
21 and such specificity and detail as the commissioner may prescribe, with  
22 a copy of such report furnished at the same time to the agent or project  
23 operator. This report may be made in conjunction with the statement  
24 required by subdivision nine of section eight hundred seventy-four of  
25 this article or it may be made as a separate report, at the discretion  
26 of the commissioner. An agent or project operator or other person or  
27 entity shall not avail itself of state or local sales and use tax  
28 exemptions in excess of the amount or in contravention of the time and

1 other limitations set out in such report or for property or services  
2 other than those set out in such report. An IDA that fails to make such  
3 records available to the commissioner or to the state comptroller or to  
4 file such report or to comply with any other requirement of this subdi-  
5 vision shall be prohibited from providing state sales and use tax  
6 exemption benefits for any project unless and until such IDA comes into  
7 compliance with all such requirements.

8 4. Notwithstanding any provision of this section or other law, in no  
9 case shall an IDA agent, project operator, or other person or entity  
10 take any state sales and use tax exemption benefits as exemptions at the  
11 time of purchase or use. Rather, in all cases, the person or entity  
12 shall pay state sales or use tax to the person required to collect it at  
13 the time of purchase or to the commissioner in accord with the require-  
14 ments of article twenty-eight of the tax law. After having paid tax to  
15 the person required to collect it or to the commissioner, such person or  
16 entity may then apply to the commissioner for a refund or credit of such  
17 tax actually paid. Any such refund or credit shall then be applied for  
18 in the manner established by and subject to the provisions of such arti-  
19 cle twenty-eight.

20 5. Notwithstanding any provision of this section or other law, an IDA  
21 shall not create a project or any portion of a project, or authorize the  
22 use of any project or project property, outside this state.

23 6. An IDA that enters into an agreement requiring payments in lieu of  
24 state sales and use taxes to be paid to it shall remit the full amount  
25 of any such payments it receives to the commissioner within thirty days  
26 of the date that the IDA receives the payment, together with a return or  
27 report required by the commissioner. The IDA shall send a copy of any  
28 such agreement for payment in lieu of such taxes to the commissioner

1 within thirty days of the date it is executed. If the person or entity  
2 required to make such payments to the IDA fails to do so timely, or if  
3 the IDA fails to remit such payments to the commissioner timely, the  
4 amount of any such untimely payments or remissions, together with a  
5 penalty of five percent of the amount of such late payments and interest  
6 on such late payments at the rate of one percent per month, shall all  
7 be deemed to be sales tax which a return or report shows to be due under  
8 section one hundred seventy-three-a of the tax law and such amounts  
9 shall be paid upon notice and demand and shall be assessed, collected,  
10 and paid in the manner provided for sales tax, and such notice and  
11 demand shall not be considered as a notice of determination, as  
12 described in such section one hundred seventy-three-a. An IDA shall join  
13 the commissioner as a party in any action or proceeding that the IDA  
14 commences to recover, obtain, or otherwise seek, any unpaid payments in  
15 lieu of state sales and use tax from an agent, project operator or other  
16 person or entity. The provisions of this subdivision shall also apply to  
17 any interest or penalty that the IDA imposes on any such payments in  
18 lieu of taxes or that are imposed on such payments by operation of law  
19 or by judicial order or otherwise. Any such payments, together with any  
20 interest or penalties thereon, shall be deemed to be state sales and use  
21 taxes and the IDA shall receive any such payments, whether as a result  
22 of court action or otherwise, as trustee for and on account of the  
23 state.

24 7. An IDA or IDA agent or project operator shall not be exempt from  
25 the taxes imposed by paragraph ten of subdivision (c) of section eleven  
26 hundred five or by article twenty-eight-A or twenty-nine-A of the tax  
27 law.

1 8. If an IDA recovers, recaptures, receives, or otherwise obtains, any  
2 amount of state sales and use tax exemption benefits from an agent,  
3 project operator or other person or entity, the IDA shall, within thirty  
4 days of coming into possession of such amount, remit it to the commis-  
5 sioner, together with such information and report that the commissioner  
6 deems necessary to administer payment over of such amount. An IDA shall  
7 join the commissioner as a party in any action or proceeding that the  
8 IDA commences to recover, recapture, obtain, or otherwise seek the  
9 return of, state sales and use tax exemption benefits from an agent,  
10 project operator or other person or entity. This subdivision shall  
11 apply to any amounts of state sales and use tax exemption benefits that  
12 an IDA recovers, recaptures, receives, or otherwise obtains, regardless  
13 of whether the IDA or the agent, project operator or other person or  
14 entity characterizes such benefits recovered, recaptured, received, or  
15 otherwise obtained, as a penalty or liquidated or contract damages or  
16 otherwise. The provisions of this subdivision shall also apply to any  
17 interest or penalty that the IDA imposes on any such amounts or that are  
18 imposed on such amounts by operation of law or by judicial order or  
19 otherwise. Any such amounts or payments that an IDA recovers, recap-  
20 tures, receives, or otherwise obtains, together with any interest or  
21 penalties thereon, shall be deemed to be state sales and use taxes and  
22 the IDA shall receive any such amounts or payments, whether as a result  
23 of court action or otherwise, as trustee for and on account of the  
24 state.

25 9. The commissioner shall deposit and dispose of any amount of any  
26 payments or moneys received from or paid over by an IDA or from or by  
27 any person or entity, or received pursuant to an action or proceeding  
28 commenced by an IDA, together with any interest or penalties thereon,

1 pursuant to subdivision six or eight of this section, as state sales and  
2 use taxes in accord with the provisions of article twenty-eight of the  
3 tax law. The amount of any such payments or moneys, together with any  
4 interest or penalties thereon, shall be attributed to the taxes imposed  
5 by sections eleven hundred five and eleven hundred ten, on the one hand,  
6 and section eleven hundred nine of the tax law, on the other hand, or to  
7 any like taxes or fees imposed by such article, based on the proportion  
8 that the rates of such taxes or fees bear to each other, unless there is  
9 evidence to show that only one or the other of such taxes or fees was  
10 imposed or received or paid over.

11 10. The statement that an IDA is required by subdivision nine of  
12 section eight hundred seventy-four of this article to file with the  
13 commissioner shall not be considered an exemption or other certificate  
14 or document under article twenty-eight or twenty-nine of the tax law.  
15 The IDA shall not represent to any agent, project operator, or other  
16 person or entity that a copy of such statement may serve as a sales or  
17 use tax exemption certificate or document. No agent or project operator  
18 may tender a copy of such statement to any person required to collect  
19 sales or use taxes as the basis to make any purchase exempt from tax. No  
20 such person required to collect sales or use taxes may accept such a  
21 statement in lieu of collecting any tax required to be collected. The  
22 civil and criminal penalties for misuse of a copy of such statement as  
23 an exemption certificate or document or for failure to pay or collect  
24 tax shall be as provided in the tax law. In addition, the use by an IDA  
25 or agent, project operator, or other person or entity of such statement,  
26 or the IDA's recommendation of the use or tendering of such statement,  
27 as such an exemption certificate or document shall be deemed to be,  
28 under articles twenty-eight and thirty-seven of the tax law, the issu-

1 ance of a false or fraudulent exemption certificate or document with  
2 intent to evade tax.

3 11. In consultation with the commissioner of economic development, the  
4 commissioner of taxation and finance is hereby authorized to adopt rules  
5 and regulations and to issue publications and other guidance implement-  
6 ing the provisions of this section and of the other sections of this  
7 article relating to any state or local tax or fee, or exemption or  
8 exclusion therefrom, that the commissioner administers and that may be  
9 affected by any provision of this article, and any such rules and regu-  
10 lations of the commissioner shall have the same force and effect with  
11 respect to such taxes and fees, or amounts measured in respect of them,  
12 as if they had been adopted by the commissioner pursuant to the authori-  
13 ty of the tax law.

14 12. To the extent that a provision of this section conflicts with a  
15 provision of any other section of this article, the provisions of this  
16 section shall control.

17 § 2. The public authorities law is amended by adding a new section  
18 1963-b to read as follows:

19 § 1963-b. Special provisions applicable to state sales and compensat-  
20 ing use taxes and certain types of facilities. The provisions of section  
21 eight hundred seventy-five of the general municipal law shall apply to  
22 the provisions of this title and to the authority created by this title  
23 with the same force and effect as if the provisions of such section  
24 eight hundred seventy-five had been incorporated in full into this title  
25 and had expressly referred to the provisions of this title and to such  
26 authority, with such changes to such section as are necessary to refer  
27 to the provisions of this title and to the authority created by this  
28 title.

1 § 3. The public authorities law is amended by adding a new section  
2 2326-a to read as follows:

3 § 2326-a. Special provisions applicable to state sales and compensat-  
4 ing use taxes and certain types of facilities. The provisions of section  
5 eight hundred seventy-five of the general municipal law shall apply to  
6 the provisions of this title and to the authority created by this title  
7 with the same force and effect as if the provisions of such section  
8 eight hundred seventy-five had been incorporated in full into this title  
9 and had expressly referred to the provisions of this title and to such  
10 authority, with such changes to such section as are necessary to refer  
11 to the provisions of this title and to the authority created by this  
12 title.

13 § 4. Subdivision 3 of section 810 of the general municipal law, as  
14 amended by chapter 356 of the laws of 1993, is amended to read as  
15 follows:

26 employees of each industrial development agency and authority estab-  
27 lished by this chapter or created by the public authorities law shall be



1 deemed officers or employees of the county, city, village, or town for  
2 whose benefit such agency or authority is established or created.

3 § 5. Subdivision 4 of section 854 of the general municipal law, as  
4 amended by chapter 478 of the laws of 2011, is amended to read as  
5 follows:

6 (4) "Project" - shall mean any land, any building or other improve-  
7 ment, and all real and personal properties located within the state of  
8 New York and within or outside or partially within and partially outside  
9 the municipality for whose benefit the agency was created, including,  
10 but not limited to, machinery, equipment and other facilities deemed  
11 necessary or desirable in connection therewith, or incidental thereto,  
12 whether or not now in existence or under construction, which shall be  
13 suitable for manufacturing, warehousing, research, commercial or indus-  
14 trial purposes or other economically sound purposes identified and  
15 called for to implement a state designated urban cultural park manage-  
16 ment plan as provided in title G of the parks, recreation and historic  
17 preservation law and which may include or mean an industrial pollution  
18 control facility, a recreation facility, educational or cultural facili-  
19 ty, a horse racing facility, a railroad facility or an automobile racing  
20 facility, provided, however, no agency shall use its funds or provide  
21 financial assistance in respect of any project wholly or partially  
22 outside the municipality for whose benefit the agency was created with-  
23 out the prior consent thereto by the governing body or bodies of all the  
24 other municipalities in which a part or parts of the project is, or is  
25 to be, located, and such portion of the project located outside such

12 purposes of providing financial assistance consisting of any sales and  
13 compensating use tax exemption to such person, the agency shall file a  
14 statement with the department of taxation and finance relating thereto,  
15 on a form and in such manner as is prescribed by the commissioner of  
16 taxation and finance, identifying each such agent so named by the agen-  
17 cy, setting forth the taxpayer identification number of each such agent,  
18 giving a brief description of the property and/or services intended to  
19 be exempted from such taxes as a result of such appointment as agent,

7 § 8. Subdivision 4 of section 1963 of the public authorities law, as  
8 added by section 2 of subpart C of part S of chapter 57 of the laws of  
9 2010, is amended to read as follows;

10 4. (a) Within thirty days of the date that the authority designates a  
11 project operator or other person to act as agent of the authority for  
12 purposes of providing financial assistance consisting of any sales and  
13 compensating use tax exemption to such person, the agency shall file a  
14 statement with the department of taxation and finance relating thereto,  
15 on a form and in such manner as is prescribed by the commissioner of  
16 taxation and finance, identifying each such agent so named by the  
17 authority, setting forth the taxpayer identification number of each such  
18 agent, giving a brief description of the property and/or services  
19 intended to be exempted from such taxes as a result of such appointment  
20 as agent, indicating the authority's rough estimate of the value of the

23 false, (iii) willfully fails to comply with the provisions of paragraph  
24 two or three of subdivision (e) of section eleven hundred thirty-seven  
25 of this article, (iv) willfully fails to prepay, collect, truthfully  
26 account for or pay over any tax imposed under this article or pursuant

1 to the authority of article twenty-nine of this chapter, (v) fails to

6 (C) In any of the foregoing instances where the commissioner may  
7 suspend or revoke or refuse to issue a certificate of authority, the  
8 commissioner may condition the retention or issuance of a certificate of  
9 authority upon (i) the filing of a bond [or], (ii) the deposit of tax in  
10 the manner provided in paragraph two or three of subdivision (e) of  
11 section eleven hundred thirty-seven of this part, (iii) notwithstanding  
12 paragraph two of subdivision (a) of this section, the issuance of such  
13 certificate for a specified term of less than three years, (iv) the  
14 filing of part-quarterly returns pursuant to paragraph two of subdivi-  
15 sion (a) of section eleven hundred thirty-six of this part, (v) the  
16 filing of any unfiled returns, (vi) entering into an installment payment

25 a person was notified that such person's certificate of authority was  
26 deemed to expire pursuant to paragraph five of subdivision (a) of this  
27 section and such person has failed to renew such certificate or obtain a  
28 new certificate of authority, or where a person required to collect tax

1 has failed to apply for such certificate of authority, any such person  
2 is prohibited from engaging in any business in this state for which a

4 person continues to be so engaged in business, the commissioner may

9 a valid certificate of authority, (A) sells tangible personal property  
10 or services subject to tax, receives amusement charges or operates a  
11 hotel, (B) purchases or sells tangible personal property for resale, (C)  
12 sells petroleum products, or (D) sells cigarettes shall, in addition to  
13 any other penalty imposed by this chapter, be subject to a penalty in an  
14 amount [not exceeding] of five hundred dollars [for the first] a day  
15 from the first day on which such sales or purchases are made, [plus an  
16 amount not exceeding two hundred dollars for each subsequent day on  
17 which such sales or purchases are made,] not to exceed [ten] twenty  
18 thousand dollars in the aggregate. The willful failure to obtain or  
19 maintain a valid certificate of authority shall be subject to a penalty  
20 in an amount of one thousand dollars a day from the first day such sales  
21 or purchases are made, not to exceed fifty thousand dollars in the  
22 aggregate, in addition to the penalties imposed by subdivision (b) of  
23 section eighteen hundred seventeen of this article, or any other penalty  
24 imposed by this chapter. For the purposes of this section, the penalty  
25 for the willful failure to obtain or maintain a valid certificate of

6 (ii) Any person who fails to surrender a certificate of authority when  
7 a notice of revocation, expiration or suspension has become final shall,  
8 in addition to any other penalty imposed by this chapter, be subject to  
9 a penalty in an amount not exceeding five hundred dollars [for the first  
10 day of such failure, together with a penalty in an amount not exceeding  
11 two hundred dollars for each subsequent] a day [of] for such failure,  
12 not to exceed [ten] twenty thousand dollars in the aggregate.

13 (iii) Any person described in paragraph one or two of subdivision (a)  
14 of section eleven hundred thirty-four of this part who takes possession  
15 of or pays for business assets under circumstances requiring notifica-  
16 tion by such person to the [tax commission] commissioner pursuant to  
17 subdivision (c) of section eleven hundred forty-one of this part without  
18 having filed a certificate of registration pursuant to section eleven  
19 hundred thirty-four of this part shall, in addition to any other penalty  
20 imposed by this chapter, be subject to a penalty in an amount not  
21 exceeding two [hundred] thousand dollars.

22 (iv) If the [tax commission] commissioner determines that any failure  
23 or act described in this paragraph was due to reasonable cause and not  
24 due to willful neglect, [it] he or she may remit all or part of such  
25 penalty. Provided, however, this clause shall not apply to a penalty for  
26 the willful failure to obtain a certificate of authority.

9 penalty of [fifty] one hundred dollars. If the [tax commission] commis-

11 due to willful neglect], [it] he or she may remit all or part of such  
12 penalty.

13 § 7. Subdivision (g) of section 1146 of the tax law, as added by chap-  
14 ter 577 of the laws of 1997, is amended to read as follows:

15 (g) (1) Notwithstanding the provisions of subdivision (a) of this  
16 section, if the commissioner determines that a person required to  
17 collect tax is liable for any tax, penalty or interest under this arti-  
18 cle or is liable for a penalty under subdivision (e) of section eleven  
19 hundred forty-five of this [article] part with respect to any failure,  
20 upon request in writing of such person, the commissioner shall disclose  
21 in writing to such person [(1)] (i) the name of any other person  
22 required to collect tax or any other person liable for such penalty  
23 under such subdivision (e) whom the commissioner has determined to be  
24 liable for the same tax, penalty or interest or for such penalty with  
25 respect to such failure, and [(2)] (ii) whether the commissioner has  
26 attempted to collect such tax, penalty or interest or such penalty from

28 the amount collected.



1 (2) Notwithstanding any provision of this chapter to the contrary, for

4 determines that any tax imposed under this chapter or any related stat-  
5 ute, as defined in section eighteen hundred of this chapter, has been  
6 finally determined to be due from a person required to collect tax and  
7 has not been paid, upon written request of the person who filed the  
8 certificate of registration for a certificate of authority that was  
9 refused, the commissioner may disclose to such person the name of the  
10 person or persons required to collect tax whose tax liability or liabil-  
11 ities were grounds for the refusal to issue the certificate of authority  
12 and the amount or amounts of tax due for each such person or persons.

13 § 8. Subdivisions (a) and (b) of section 1817 of the tax law, as  
14 amended by section 53 of part K of chapter 61 of the laws of 2011, are  
15 amended to read as follows:

16 (a) Any person required to obtain a certificate of authority under  
17 section eleven hundred thirty-four of this chapter who, without possess-  
18 ing a valid certificate of authority, or possessing a certificate of  
19 authority that was deemed to have expired pursuant to paragraph five of  
20 subdivision (a) of section eleven hundred thirty-four of this chapter  
21 willfully (1) sells tangible personal property or services subject to  
22 tax, receives amusement charges or operates a hotel, (2) purchases or  
23 sells tangible personal property for resale, or (3) sells petroleum  
24 products; and any person who fails to surrender a certificate of author-  
25 ity as required by such article shall be guilty of [a misdemeanor] crim-  
26 inal tax fraud in the fifth degree.

27 (b) Any person required to obtain a certificate of authority under  
28 section eleven hundred thirty-four of this chapter who within five years

1 after a determination by the commissioner[, ] pursuant to such section[, ]  
2 to suspend, revoke or refuse to issue a certificate of authority has  
3 become final, or was notified by the commissioner that the person's  
4 certificate of authority was deemed to have expired pursuant to para-  
5 graph five of subdivision (a) of section eleven hundred thirty-four of  
6 this chapter, and without possession of a valid certificate of authority  
7 willfully (1) sells tangible personal property or services subject to  
8 tax, receives amusement charges or operates a hotel, (2) purchases or  
9 sells tangible personal property for resale, or (3) sells petroleum  
10 products, shall be guilty of [a misdemeanor] criminal tax fraud in the  
11 fourth degree. It shall be an affirmative defense that such person  
12 performed the acts described in this subdivision without knowledge of  
13 such determination. Any person who violates a provision of this subdivi-  
14 sion, upon conviction, shall be subject to a fine in any amount author-  
15 ized by this article, but not less than five hundred dollars, in addi-  
16 tion to any other penalty provided by law.

17 § 9. This act shall take effect immediately, provided that the amend-  
18 ments to subparagraph (A) of paragraph 4 of subdivision (a) of section  
19 1134 of the tax law made by section one of this act shall be subject to

16 (d) Except as otherwise provided in this section, all the provisions  
17 of article twenty-eight of this chapter relating to the personal liabil-  
18 ity for the tax, administration, collection and determination of tax,  
19 and deposit and disposition of revenue, including section eleven hundred  
20 thirty-eight of this chapter relating to determination of tax and  
21 section eleven hundred forty-five of this chapter (but only paragraphs  
22 one and two of subdivision (a) of such section) relating to penalties  
23 and interest for failure to file a return or pay tax within the time  
24 required, shall apply to the applications for registration and the fees  
25 for filing such applications required by this section and the penalty  
26 imposed pursuant to subdivision three of this section, as if such appli-  
27 cations were returns required under section eleven hundred thirty-six of  
28 this chapter and such filing fees, penalties and interest were taxes

1 required to be paid pursuant to such article twenty-eight, in the same

1 § 3. This act shall take effect immediately and shall apply to certif-  
2 icates of registration applications filed for calendar year 2014 and  
3 thereafter.

5 Section 1. Subparagraph (i) of paragraph (b) of subdivision 1 of  
6 section 481 of the tax law, as amended by chapter 604 of the laws of  
7 2008, is amended to read as follows:

8 (i) In addition to any other penalty imposed by this article, the  
9 commissioner may (A) impose a penalty of not more than [one] six hundred  
10 [fifty] dollars for each two hundred cigarettes, or fraction thereof, in  
11 excess of one thousand cigarettes in unstamped or unlawfully stamped  
12 packages in the possession or under the control of any person or (B)  
13 impose a penalty of not more than two hundred dollars for each ten unaf-  
14 fixed false, altered or counterfeit cigarette tax stamps, imprints or  
15 impressions, or fraction thereof, in the possession or under the control  
16 of any person. In addition, the commissioner may impose a penalty of not  
17 more than seventy-five dollars for each fifty cigars or one pound of  
18 tobacco, or fraction thereof, in excess of two hundred fifty cigars or  
19 five pounds of tobacco in the possession or under the control of any  
20 person and a penalty of not more than one hundred fifty dollars for each  
21 fifty cigars or pound of tobacco, or fraction thereof, in excess of five  
22 hundred cigars or ten pounds of tobacco in the possession or under the  
23 control of any person, with respect to which the tobacco products tax  
24 has not been paid or assumed by a distributor or tobacco products deal-  
25 er; provided, however, that any such penalty imposed shall not exceed  
26 seven thousand five hundred dollars in the aggregate. The commissioner

1 may impose a penalty of not more than seventy-five dollars for each  
2 fifty cigars or one pound of tobacco, or fraction thereof, in excess of  
3 fifty cigars or one pound of tobacco in the possession or under the  
4 control of any tobacco products dealer or distributor appointed by the  
5 commissioner, and a penalty of not more than one hundred fifty dollars  
6 for each fifty cigars or pound of tobacco, or fraction thereof, in  
7 excess of two hundred fifty cigars or five pounds of tobacco in the  
8 possession or under the control of any such dealer or distributor, with  
9 respect to which the tobacco products tax has not been paid or assumed  
10 by a distributor or a tobacco products dealer; provided, however, that  
11 any such penalty imposed shall not exceed fifteen thousand dollars in  
12 the aggregate.

13 § 2. This act shall take effect June 1, 2013.

14 PART P

15 Section 1. The tax law is amended by adding a new section 171-v to  
16 read as follows:

17 § 171-v. Enforcement of delinquent tax liabilities through the suspen-  
18 sion of drivers' licenses. (1) The commissioner shall enter into a writ-  
19 ten agreement with the commissioner of motor vehicles, which shall set  
20 forth the procedures for the two departments to cooperate in a program  
21 to improve tax collection through the suspension of drivers' licenses of  
22 taxpayers with past-due tax liabilities equal to or in excess of ten  
23 thousand dollars. For the purposes of this section, the term "tax  
24 liabilities" shall mean any tax, surcharge, or fee administered by the  
25 commissioner, or any penalty or interest due on these amounts owed by an  
26 individual with a New York driver's license, the term "driver's license"

1 means any license issued by the department of motor vehicles, except for  
2 a commercial driver's license as defined in section five hundred one-a  
3 of the vehicle and traffic law, and the term "past-due tax liabilities"  
4 means any tax liability or liabilities which have become fixed and final  
5 such that the taxpayer no longer has any right to administrative or  
6 judicial review.

7 (2) The agreement shall include the following provisions:

8 (a) the procedures by which the department shall notify the commis-  
9 sioner of motor vehicles of taxpayers with past-due tax liabilities,  
10 including the procedures by which the department and the department of  
11 motor vehicles shall share the information necessary to identify indi-  
12 viduals with past-due tax liabilities, which shall include a taxpayer's  
13 name, social security number, and any other information necessary to  
14 ensure the proper identification of the taxpayer;

15 (b) the procedures by which the commissioner shall notify the depart-  
16 ment of motor vehicles that a taxpayer has satisfied his or her past-due  
17 tax liabilities, or has entered into an installment payment agreement or  
18 has otherwise made payment arrangements satisfactory to the commission-  
19 er, so that the suspension of the taxpayer's driver's license may be  
20 lifted; and

21 (c) any other matter the department and the department of motor vehi-  
22 cles shall deem necessary to carry out the provisions of this section.

23 (3) The department shall provide notice to the taxpayer of his or her  
24 inclusion in the license suspension program no later than forty-five  
25 days prior to the date the department intends to inform the commissioner  
26 of motor vehicles of the taxpayer's inclusion. However, no such notice  
27 shall be issued to a taxpayer whose wages are being garnished by the  
28 department for the payment of past-due tax liabilities or past-due child

1 support or combined child and spousal support arrears. Notice shall be  
2 provided by first class mail to the taxpayer's last known address as  
3 such address appears in the electronic systems or records of the depart-  
4 ment. Such notice shall include:

5 (a) a clear statement of the past-due tax liabilities along with a  
6 statement that the department shall provide to the department of motor  
7 vehicles the taxpayer's name, social security number and any other iden-  
8 tifying information necessary for the purpose of suspending his or her  
9 driver's license pursuant to this section and subdivision four-f of  
10 section five hundred ten of the vehicle and traffic law forty-five days  
11 after the mailing or sending of such notice to the taxpayer;

12 (b) a statement that the taxpayer may avoid suspension of his or her  
13 license by fully satisfying the past-due tax liabilities or by making  
14 payment arrangements satisfactory to the commissioner, and information  
15 as to how the taxpayer can pay the past-due tax liabilities to the  
16 department, enter into a payment arrangement or request additional  
17 information;

18 (c) a statement that the taxpayer's right to protest the notice is  
19 limited to raising issues set forth in subdivision five of this section;

20 (d) a statement that the suspension of the taxpayer's driver's license  
21 shall continue until the past-due tax liabilities are fully paid or the  
22 taxpayer makes payment arrangements satisfactory to the commissioner;  
23 and

24 (e) any other information that the commissioner deems necessary.

25 (4) After the expiration of the forty-five day period, if the taxpayer  
26 has not challenged the notice pursuant to subdivision five of this  
27 section and the taxpayer has failed to satisfy the past-due tax liabil-  
28 ities or make payment arrangements satisfactory to the commissioner, the



1 department shall notify the department of motor vehicles, in the manner  
2 agreed upon by the two agencies, that the taxpayer's driver's license  
3 shall be suspended pursuant to subdivision four-f of section five  
4 hundred ten of the vehicle and traffic law; provided, however, in any  
5 case where a taxpayer fails to comply with the terms of a current  
6 payment arrangement more than once within a twelve month period, the  
7 commissioner shall immediately notify the department of motor vehicles  
8 that the taxpayer's driver's license shall be suspended.

9 (5) Notwithstanding any other provision of law, and except as specif-  
10 ically provided herein, the taxpayer shall have no right to commence a  
11 court action or proceeding or to any other legal recourse against the  
12 department or the department of motor vehicles regarding a notice issued  
13 by the department pursuant to this section and the referral by the  
14 department of any taxpayer with past-due tax liabilities to the depart-  
15 ment of motor vehicles pursuant to this section for the purpose of  
16 suspending the taxpayer's driver's license. A taxpayer may only chal-  
17 lenge such suspension or referral on the grounds that (i) the individual  
18 to whom the notice was provided is not the taxpayer at issue; (ii) the  
19 past-due tax liabilities were satisfied; (iii) the taxpayer's wages are  
20 being garnished by the department for the payment of the past-due tax  
21 liabilities at issue or for past-due child support or combined child and  
22 spousal support arrears; (iv) the taxpayer's wages are being garnished  
23 for the payment of past-due child support or combined child and spousal  
24 support arrears pursuant to an income execution issued pursuant to  
25 section five thousand two hundred forty-one of the civil practice law  
26 and rules; (v) the taxpayer's driver's license is a commercial driver's  
27 license as defined in section five hundred one-a of the vehicle and  
28 traffic law; or (vi) the department incorrectly found that the taxpayer

1 has failed to comply with the terms of a payment arrangement made with  
2 the commissioner more than once within a twelve month period for the  
3 purposes of subdivision three of this section.

4 However, nothing in this subdivision is intended to limit a taxpayer  
5 from seeking relief from joint and several liability pursuant to section  
6 six hundred fifty-four of this chapter, to the extent that he or she is  
7 eligible pursuant to that subdivision, or establishing to the department  
8 that the enforcement of the underlying tax liabilities has been stayed  
9 by the filing of a petition pursuant to the Bankruptcy Code of 1978  
10 (Title Eleven of the United States Code).

11 (6) Notwithstanding any provision of this chapter to the contrary, the  
12 department may disclose to the department of motor vehicles the informa-  
13 tion described in this section that, in the discretion of the commis-  
14 sioner, is necessary for the proper identification of a taxpayer  
15 referred to the department of motor vehicles for the purpose of suspend-  
16 ing the taxpayer's driver's license pursuant to this section and subdi-  
17 vision four-f of section five hundred ten of the vehicle and traffic  
18 law. The department of motor vehicles may not redisclose this informa-  
19 tion to any other entity or person, other than for the purpose of  
20 informing the taxpayer that his or her driver's license has been  
21 suspended.

22 (7) Except as otherwise provided in this section, the activities to  
23 collect past-due tax liabilities undertaken by the department pursuant  
24 to this section shall not in any way limit, restrict or impair the  
25 department from exercising any other authority to collect or enforce tax  
26 liabilities under any other applicable provision of law.

27 § 2. Section 510 of the vehicle and traffic law is amended by adding a  
28 new subdivision 4-f to read as follows:

1 4-f. Suspension for failure to pay past-due tax liabilities. (1) The  
2 commissioner shall enter into a written agreement with the commissioner  
3 of taxation and finance, as provided in section one hundred  
4 seventy-one-v of the tax law, which shall set forth the procedures for  
5 suspending the drivers' licenses of individuals who have failed to  
6 satisfy past-due tax liabilities as such terms are defined in such  
7 section.

8 (2) Upon receipt of notification from the department of taxation and  
9 finance that an individual has failed to satisfy past-due tax liabil-  
10 ities, or to otherwise make payment arrangements satisfactory to the  
11 commissioner of taxation and finance, or has failed to comply with the  
12 terms of such payment arrangements more than once within a twelve month  
13 period, the commissioner or his or her agent shall suspend the license  
14 of such person to operate a motor vehicle. In the event such person is  
15 unlicensed, such person's privilege of obtaining a license shall be  
16 suspended. Such suspension shall take effect no later than fifteen days  
17 from the date of the notice thereof provided to the person whose license  
18 or privilege of obtaining a license is to be suspended, and shall remain  
19 in effect until such time as the commissioner is advised that the person  
20 has satisfied his or her past-due tax liabilities, or has otherwise made  
21 payment arrangements satisfactory to the commissioner of taxation and  
22 finance.

23 (3) From the time the commissioner is notified by the department of  
24 taxation and finance under this section, the commissioner shall be  
25 relieved from all liability to such person which may otherwise arise  
26 under this section, and such person shall have no right to commence a  
27 court action or proceeding or to any other legal recourse against the  
28 commissioner to recover such driving privileges as authorized by this

1 section. In addition, notwithstanding any other provision of law, such  
2 person shall have no right to a hearing or appeal pursuant to this chap-  
3 ter with respect to a suspension of driving privileges as authorized by  
4 this section.

5 (4) Notwithstanding any provision of law to the contrary, the depart-  
6 ment shall furnish the department of taxation and finance with the  
7 information necessary for the proper identification of an individual  
8 referred to the department for the purpose of driver's license suspen-  
9 sion pursuant to this section and section one hundred seventy-one-v of  
10 the tax law. This shall include the individual's name, social security  
11 number and any other information the commissioner of motor vehicles  
12 deems necessary.

13 (5) Any person whose driver's license is suspended pursuant to para-  
14 graph two of this subdivision may apply for the issuance of a restricted  
15 use license as provided in section five hundred thirty of this title.

16 § 3. Subdivision 7 of section 511 of the vehicle and traffic law, as  
17 added by chapter 81 of the laws of 1995, is amended to read as follows:

18 7. Exceptions. When a person is convicted of a violation of subdivi-  
19 sion one [of] or two of this section, and the suspension was issued  
20 pursuant to (a) subdivision four-e of section five hundred ten of this  
21 article due to a support arrears, or (b) subdivision four-f of section  
22 five hundred ten of the article due to past-due tax liabilities, the  
23 mandatory penalties set forth in subdivision one or two of this section  
24 shall not be applicable if, on or before the return date or subsequent  
25 adjourned date, such person presents proof that such support arrears or  
26 past-due tax liabilities have been satisfied as shown by certified  
27 check, notice issued by the court ordering the suspension, or notice  
28 from a support collection unit or department of taxation and finance as

1 applicable. The sentencing court shall take the satisfaction of arrears  
2 or the payment of the past-due tax liabilities into account when impos-  
3 ing a sentence for any such conviction. For licenses suspended for non-  
4 payment of past-due tax liabilities, the court shall also take into  
5 consideration proof, in the form of a notice from the department of  
6 taxation and finance, that such person has made payment arrangements  
7 that are satisfactory to the commissioner of taxation and finance.

8 § 4. Section 530 of the vehicle and traffic law is amended by adding a  
9 new subdivision 5-b to read as follows:

10 (5-b) Issuance of a restricted license shall not be denied to any  
11 person whose license is suspended pursuant to subdivision four-f of  
12 section five hundred ten of this title for any reason other than such  
13 person's failure to otherwise have a valid or renewable driver's  
14 license. The restrictions on the types of vehicles which may be operated  
15 with a restricted license contained in such subdivision five of this  
16 section shall not be applicable to a restricted license issued to a  
17 person pursuant to subdivision four-f of section five hundred ten of  
18 this title. The issuance of a restricted license issued as a result of a  
19 suspension under subdivision four-f of section five hundred ten of this  
20 title shall not in any way affect a person's eligibility for a  
21 restricted license at some future time.

22 § 5. Section 2335-a of the insurance law, as added by chapter 152 of  
23 the laws of 1998, is amended to read as follows:

24 § 2335-a. Prohibition of rate increases for persons involved in emer-  
25 gency use of vehicles or due to a driver's license suspension for past-  
26 due tax liabilities.

27 (a) No insurer authorized to transact or transacting business in this  
28 state, or controlling or controlled by or under common control by or

1 with an insurer authorized to transact or transacting business in this  
2 state, [which] that sells a policy providing motor vehicle liability  
3 insurance coverage in this state, shall increase the policy premium in  
4 connection with the insurance permitted or required by this chapter  
5 solely because the insured or any other person who customarily operates  
6 an automobile covered by the policy has had an accident while operating  
7 a motor vehicle in response to an emergency, where the insured was  
8 either responding to a call to duty as a paid or volunteer member of any  
9 police or fire department or first aid squad[;], or was performing any  
10 other function on behalf of the state, any political subdivision there-  
11 of, a public authority, public benefit corporation, or any other govern-  
12 mental agency or instrumentality in a public emergency.

13 (b) No insurer authorized to transact or transacting business in this  
14 state, or controlling or controlled by or under common control by or  
15 with an insurer authorized to transact or transacting business in this  
16 state, that sells a policy providing motor vehicle insurance coverage in  
17 this state shall increase the policy premium in connection with the  
18 insurance permitted or required by this chapter solely because the  
19 insured or any other person who customarily operates an automobile  
20 covered by the policy has had his or her driver's license suspended  
21 pursuant to subdivision four-f of section five hundred ten of the vehi-  
22 cle and traffic law for past-due tax liabilities, as defined in section  
23 one hundred seventy-one-v of the tax law, or has applied for or received  
24 a restricted use license as provided for by section five hundred thirty  
25 of the vehicle and traffic law, as the result of such suspension.

26 § 6. The insurance law is amended by adding a new section 2616 to read  
27 as follows:

1 § 2616. Discrimination because of a driver's license suspension for  
2 past-due tax liabilities. An individual or entity shall not refuse to  
3 issue any policy of motor vehicle insurance, or cancel or decline to  
4 renew such policy, because the applicant or policy holder has had his or  
5 her driver's license suspended pursuant to subdivision four-f of section  
6 five hundred ten of the vehicle and traffic law for past-due tax liabil-  
7 ities, as defined in section one hundred seventy-one-v of the tax law,  
8 or has applied for or received a restricted use license, as provided for  
9 by section five hundred thirty of the vehicle and traffic law, as the  
10 result of such suspension.

11 § 7. This act shall take effect immediately; provided, however, that  
12 the department of taxation and finance and the department of motor vehi-  
13 cles shall have up to six months after this act shall have become a law  
14 to execute the written agreement and implement the necessary procedures  
15 as described in sections one and two of this act.

16 PART Q

17 Section 1. The tax law is amended by adding a new section 174-c to  
18 read as follows:

2 foreign country, subject to the following provisions; provided, however,  
3 no such written agreement shall be required of a franchised corporation  
4 licensed in accordance with section one thousand seven of this article:

5 § 6. The opening paragraph of section 1018 of the racing, pari-mutuel  
6 wagering and breeding law, as amended by section 6 of part 0 of chapter  
7 59 of the laws of 2012, is amended to read as follows:

8 Notwithstanding any other provision of this chapter, for the period  
9 commencing July twenty-fifth, two thousand one [through September  
10 eighth, two thousand twelve], when a franchised corporation is conduct-  
11 ing a race meeting within the state at Saratoga Race Course, every off-  
12 track betting corporation branch office and every simulcasting facility  
13 licensed in accordance with section one thousand seven (that has entered  
14 into a written agreement with such facility's representative horsemen's  
15 organization as approved by the board), one thousand eight or one thou-  
16 sand nine of this article shall be authorized to accept wagers and  
17 display the live simulcast signal from thoroughbred tracks located in  
18 another state, provided that such facility shall accept wagers on races  
19 run at all in-state thoroughbred tracks which are conducting racing  
20 programs subject to the following provisions; provided, however, no such  
21 written agreement shall be required of a franchised corporation licensed  
22 in accordance with section one thousand seven of this article.

23 § 7. Section 32 of chapter 281 of the laws of 1994, amending the  
24 racing, pari-mutuel wagering and breeding law and other laws relating  
25 to simulcasting, as amended by section 7 of part 0 of chapter 59 of the  
26 laws of 2012, is amended to read as follows:

27 § 32. This act shall take effect immediately [and the pari-mutuel tax  
28 reductions in section six of this act shall expire and be deemed

1 repealed on July 1, 2013]; provided, however, that nothing contained  
2 herein shall be deemed to affect the application, qualification, expira-  
3 tion, or repeal of any provision of law amended by any section of this  
4 act, and such provisions shall be applied or qualified or shall expire  
5 or be deemed repealed in the same manner, to the same extent and on the  
6 same date as the case may be as otherwise provided by law; provided  
7 further, however, that sections twenty-three and twenty-five of this act  
8 shall remain in full force and effect only until May 1, 1997 and at such  
9 time shall be deemed to be repealed.

10 § 8. Section 54 of chapter 346 of the laws of 1990, amending the  
11 racing, pari-mutuel wagering and breeding law and other laws relating to  
12 simulcasting and the imposition of certain taxes, as amended by section  
13 8 of part 0 of chapter 59 of the laws of 2012, is amended to read as  
14 follows:

15 § 54. This act shall take effect immediately; provided, however,  
16 sections three through twelve of this act shall take effect on January  
17 1, 1991, and [section 1013 of the racing, pari-mutuel wagering and  
18 breeding law, as added by section thirty-eight of this act, shall expire  
19 and be deemed repealed on July 1, 2013; and] section eighteen of this  
20 act shall take effect on July 1, 2008 and sections fifty-one and fifty-  
21 two of this act shall take effect as of the same date as chapter 772 of  
22 the laws of 1989 took effect.

23 § 9. Paragraph (a) of subdivision 1 of section 238 of the racing,  
24 pari-mutuel wagering and breeding law, as amended by section 9 of part 0  
25 of chapter 59 of the laws of 2012, is amended to read as follows:

26 (a) The franchised corporation authorized under this chapter to  
27 conduct pari-mutuel betting at a race meeting or races run thereat shall  
28 distribute all sums deposited in any pari-mutuel pool to the holders of



1 winning tickets therein, provided such tickets be presented for payment  
2 before April first of the year following the year of their purchase,  
3 less an amount which shall be established and retained by such fran-  
4 chised corporation of between twelve to seventeen per centum of the  
5 total deposits in pools resulting from on-track regular bets, and four-  
6 teen to twenty-one per centum of the total deposits in pools resulting  
7 from on-track multiple bets and fifteen to twenty-five per centum of the  
8 total deposits in pools resulting from on-track exotic bets and fifteen  
9 to thirty-six per centum of the total deposits in pools resulting from  
10 on-track super exotic bets, plus the breaks. The retention rate to be  
11 established is subject to the prior approval of the racing and wagering  
12 board. Such rate may not be changed more than once per calendar quarter  
13 to be effective on the first day of the calendar quarter. "Exotic bets"  
14 and "multiple bets" shall have the meanings set forth in section five  
15 hundred nineteen of this chapter. "Super exotic bets" shall have the  
16 meaning set forth in section three hundred one of this chapter. For  
17 purposes of this section, a "pick six bet" shall mean a single bet or  
18 wager on the outcomes of six races. The breaks are hereby defined as the  
19 odd cents over any multiple of five for payoffs greater than one dollar  
20 five cents but less than five dollars, over any multiple of ten for  
21 payoffs greater than five dollars but less than twenty-five dollars,  
22 over any multiple of twenty-five for payoffs greater than twenty-five  
23 dollars but less than two hundred fifty dollars, or over any multiple of  
24 fifty for payoffs over two hundred fifty dollars. Out of the amount so  
25 retained there shall be paid by such franchised corporation to the  
26 commissioner of taxation and finance, as a reasonable tax by the state  
27 for the privilege of conducting pari-mutuel betting on the races run at  
28 the race meetings held by such franchised corporation, the following

1 percentages of the total pool for regular and multiple bets five per  
2 centum of regular bets and four per centum of multiple bets plus twenty  
3 per centum of the breaks; for exotic wagers seven and one-half per  
4 centum plus twenty per centum of the breaks, and for super exotic bets  
5 seven and one-half per centum plus fifty per centum of the breaks. For  
6 the period June first, nineteen hundred ninety-five through September  
7 ninth, nineteen hundred ninety-nine, such tax on regular wagers shall be  
8 three per centum and such tax on multiple wagers shall be two and one-  
9 half per centum, plus twenty per centum of the breaks. For the period  
10 September tenth, nineteen hundred ninety-nine through March thirty-  
11 first, two thousand one, such tax on all wagers shall be two and six-  
12 tenths per centum and for the period commencing April first, two thou-  
13 sand one [through December thirty-first, two thousand thirteen], such  
14 tax on all wagers shall be one and six-tenths per centum, plus, in each  
15 such period, twenty per centum of the breaks. Payment to the New York  
16 state thoroughbred breeding and development fund by such franchised  
17 corporation shall be one-half of one per centum of total daily on-track  
18 pari-mutuel pools resulting from regular, multiple and exotic bets and  
19 three per centum of super exotic bets provided, however, that for the  
20 period September tenth, nineteen hundred ninety-nine through March thir-  
21 ty-first, two thousand one, such payment shall be six-tenths of one per  
22 centum of regular, multiple and exotic pools and for the period commenc-  
23 ing April first, two thousand one [through December thirty-first, two  
24 thousand thirteen], such payment shall be seven-tenths of one per centum  
25 of such pools.

26 § 10. Subdivision 5 of section 1012 of the racing, pari-mutuel wager-  
27 ing and breeding law is REPEALED.

28 § 11. This act shall take effect immediately.

1 § 2. Severability clause. If any clause, sentence, paragraph, subdivi-  
2 sion, section or part of this act shall be adjudged by any court of  
3 competent jurisdiction to be invalid, such judgment shall not affect,  
4 impair, or invalidate the remainder thereof, but shall be confined in  
5 its operation to the clause, sentence, paragraph, subdivision, section  
6 or part thereof directly involved in the controversy in which such judg-  
7 ment shall have been rendered. It is hereby declared to be the intent of  
8 the legislature that this act would have been enacted even if such  
9 invalid provisions had not been included herein.

10 § 3. This act shall take effect immediately provided, however, that  
11 the applicable effective date of Parts A through U of this act shall be  
12 as specifically set forth in the last section of such Parts.
