The amendments:

- Reappropriate and amend the 2014 two-year VLT Education Account appropriation for General Support for Public Schools;
- Makes a technical correction to the School Tax Relief (STAR) program;

- Make various technical corrections to the takeover and restructuring of failing school districts; and

# Student Grant and Award Programs

The amendments:

- Modify the Tuition Assistance Program (TAP) appropriation to include eligibility requirements for awards to applicants without lawful immigration status and to make spending from the TAP appropriation conditioned upon enactment of both the DREAM Act and the Education Tax Credit Act as proposed in Parts D and E of legislative bill numbers S. 2006 and A. 3006;
- Authorize payment of prior year liabilities for the Aid for Part-Time Study Program;
- Correct a school year reference under the Science, Technology, Engineering and Mathematics Incentive Program; and
- Clarify the definition of income for purposes of the Get On Your Feet Loan Forgiveness Program.
