STATE OPERATIONS BUDGET BILL (Senate 2000 and Assembly 3000)

ALCOHOLIC BEVERAGE CONTROL

Licensing and Wholesaler Services Program

The amendment makes a technical correction.

AUDIT AND CONTROL

The Office of State Comptroller will be prohibited from reimbursing certain travel expenses for a member of the Legislature or statewide elected official until expanded disclosure provisions are met.

CITY UNIVERSITY OF NEW YORK

Senior Colleges

The amendment clarifies that senior college performance improvement plans are subject to budget director approval.

STATE EDUCATION DEPARTMENT

Office of Prekindergarten Through Grade Twelve Education Program

The amendment modifies the appropriation to prevent the use of Office resources to process payments of School Aid increases to a school district in the event that the Legislature has failed to enact the Education Opportunity Agenda as proposed in legislative bill numbers S.2010-A and A.3010-A and/or the school district has failed to fully implement a new system of evaluations for classroom teachers and building principals.

DEPARTMENT OF ENVIRONMENTAL CONSERVATION

Fish, Wildlife and Marine Resources Program

The amendments make various technical corrections and restore a reappropriation related to the Marketing the Outdoors program.

OFFICE OF GENERAL SERVICES

Design and Construction Program

The amendments authorize State entities to utilize Design-Build contracts.

DEPARTMENT OF HEALTH

Administration Program

The amendment makes a technical correction to the personal service subtotal.

Office of Primary Care and Health Systems Management Program

The amendment makes a technical correction to the total amount available.

OFFICE FOR PEOPLE WITH DEVELOPMENTAL DISABILITIES

Central Coordination and Support Program

The amendments add reappropriation authority that would enable OPWDD to charge FY 2014 and FY 2015 Balancing Incentive Program (BIP) expenses to the Federal BIP award.

Community Services Program

The amendments add reappropriation authority that would enable OPWDD to charge FY 2014 and FY 2015 Balancing Incentive Program (BIP) expenses to the Federal BIP award.
